



# SAME-DAY REGISTRATION REQUIREMENTS SUMMARY FOR NEW REGISTRANTS

## **BASIC VOTER REGISTRATION REQUIREMENTS (NRS 293.485):**

To register to vote in Clark County, NV, at any time, the basic requirements are:

- U.S. Citizenship; and
- At least 18 years old by election day; and
- Resident in Clark County, NV, for at least 30 days; and
- Resident in your precinct for at least 10 days.

## **REQUIRED IDENTIFICATION (ID) FOR SAME-DAY REGISTRATION (NRS 293.5837, 293.5842, 293.5847):**

To register online ([www.RegisterToVoteNV.gov](http://www.RegisterToVoteNV.gov)), or in-person at an Early Voting Site or Election Day Vote Center and vote a provisional ballot (*details below*) in the current election, you must present one of these required IDs at the voting location:

- Unexpired **NEVADA** Driver's License issued by the Department of Motor Vehicles (DMV) with your name and current Clark County residential address; or
- Unexpired **NEVADA** State Identification Card issued by the DMV with your name and current Clark County residential address; or
- Unexpired **NEVADA** DMV Interim Document (temporary until permanent ID is issued) with your name and current Clark County residential address; or
- Unexpired Tribal ID with your name and current Clark County, NV, residential address.

## **ADDITIONAL PROOF OF RESIDENCY (POR) FOR SAME-DAY REGISTRATION, ONLY IF NEEDED (NRS 293.5837, 293.5842, 293.5847; NAC 293):**

**IF** your required ID (see above) does not contain your current Clark County, NV, residential address that matches your voter registration, you must also provide additional POR that lists this address along with your name. *POR does **NOT** substitute for ID but supplements it when needed.* POR that contains the required information may include one of the following:

- Military ID; or
- Utility bill; or
- Bank or credit union statement; or
- Pay check; or
- Income tax statement; or
- Mortgage, residence rental, or lease statement; or
- Vehicle registration; or
- Property tax statement; or
- Any other document issued by a government entity; or
- Temporary ID Card from the Department of Corrections or any other NV State Agency that must contain your photo and current residential address.

## **PROVISIONAL BALLOTS FOR SAME-DAY REGISTRATION (NRS 293.5837, 293.5842, 293.5847, 293.5852):**

If you register to vote online on or after the 13th day before Election Day or in-person at any Early Voting Site or Election Day Vote Center, you may only vote a provisional ballot in the current election. Your provisional ballot will have all the contests, candidates, and questions (if any) that are on a regular ballot for your precinct. It will differ from a regular ballot in that it will be counted only after verification that:

- You were qualified to cast a ballot in the current election; and
- You did not cast multiple ballots in the same election; and
- You provided required identification; and
- **IF** needed, you additionally provided acceptable proof of residency along with your ID.

## **DEADLINES FOR SAME-DAY REGISTRATION AND PROVISIONAL BALLOT VOTING**

(NRS 293.5837, 293.5842, 293.5847, 293.5852):

Present the above required ID and, if needed, proof of residency to:

- Any Early Voting Site by the close of operations on the last day of early voting; or
- Any Election Day Vote Center by 7:00 p.m. on Election Day.
