CDBG OVERVIEW

As part of development and community improvements, Clark County administers the Community Development Block Grant (CDBG) program. This program was designed to improve living conditions, increase economic opportunities, and assist low- to moderate-income populations.



2025-2026 CDBG Applications

Approximately \$6.2 Million in funding available

- \$1.2 Million for Public Services
- Up to \$5 Million for Capital Improvements and other projects

Over \$9,000,000 in total requested

1. Boost and Build Upwards BOOST by Upwards Starlym Perez


- CDBG Activity: Economic Development, Microenterprise Assistance | <u>Matrix Code 18C</u> (Boost is not a Public Service Program)
- CDBG National Objective: The Boost Program Benefits Low- to Moderate-Income (LMI) Women & Minority Microenterprise Childcare Providers w/ Personalized Coaching & Digital Tools to Optimize Operations & Revenue. This is a Limited Clientele Program (LMC).
- **Project Goals:** Expand economic opportunities for LMI licensed daycare providers by training them on essential tools and services that lower their expenses and increase their revenue, resulting in a healthy, more sustainable business model over the 12-month program.
 - Increase childcare microenterprise revenue
 - Stabilize/ Retain jobs in the childcare industry
 - Create jobs by hiring teaching assistants
 - Increase access to childcare services for families

Boost and Build Upwards

- Beneficiaries and Estimated Number Served:
 - 40 Microenterprise childcare providers
 - 30 New teaching assistant jobs created
 - 560 New kids get reliable, quality childcare
 - Provider's revenue will increase dramatically. (\$63,190 vs \$176,932 a year)
- Project Timeline: Within 12 months of award
- CDBG Request: \$440,000 CDBG Funding Request | 82% of the Total Project Cost

2. Prosperity Project Electrical JATC of Southern Nevada

- CDBG Activity: Economic Development
- CDBG National Objective: Empowering LMI Communities
- Project Goals: Job Creation initiative through the Electrical JATC of Southern Nevada. Although tuition is free, apprentices face significant expenses for tools, boots, attire, textbooks, study materials, and supplies, which are essential for their training and employment.



Prosperity Project Electrical JATC of Southern Nevada

- Beneficiaries: The project exclusively serves 60+ LMI apprenticeship students and their families upon entry to our apprenticeship programs
- Project Timeline: Within 12 months of award
- **CDBG Request:** The project is anticipated to cost \$200,000, comprising approx. 20% of the overall cost for student success

3. Tigrinya School and Soccer Training Eritrean American Community of Las Vegas

- CDBG Activity:
 - Teaching Tigrinya for our youth and adults to bridge the communication gap and for the preservation of the Eritrean Language.
 - Provide Soccer Training lead by a Soccer Coach.
- CDBG National Objective:
 - Community Development and Public Service, Serving Low- and Moderate-Income (LMI) Youth & Preventing Community Blight
 - Economic Development and Job Creation
- Project Goals:
 - Sports and Cultural education promote community engagement and reduce isolation among immigrant families, strengthening the social fabric.
 - Hiring coaches and teachers to supports economic development

Tigrinya School and Soccer Training Eritrean American Community of Las Vegas

- Beneficiaries:
 - Tigrinya Class: Eritrean, Tigray, Ethiopian Decent, and anyone who has a desire to learn Tigrinya; ages from 10 to 25 are the target beneficiary.
 - Soccer: ages 14 to 40
- Number Served: 500+
- Location: 5580 W. Flamingo RD Unit 102 Las Vegas, NV 89103
- Estimated Project Timeline: Soccer and classes will be held year round
- CDBG Request: \$100,000 to provide the most optimal impact while being about 75% of our anticipated budget.

4. Pink Chair Outreach & Education Expansion Project Hookers for Jesus

- CDBG Activity: Public Service
- CDBG National Objectives: Meet and urgent community need
- Project Goals: Pink Chair/HFJ aligns with Clark County values and goals 2.3: Access to health and social services by offering and providing vital social services to Clark County residents at no cost who are and/or who have been victims of human and sex trafficking and domestic violence, sexual exploitation, or who've been negatively impacted by the sex industry.

Pink Chair Outreach & Education Expansion Project Hookers for Jesus

- Beneficiaries/Estimated Number Served: We will serve 150 lowmoderately low-income persons, persons experiencing homelessness, and/or victim/survivors of sex and human trafficking and domestic violence in Las Vegas, NV.
- Project Timeline: July 1, 2025, to June 30, 2026
- CDBG Request: \$75,000.00 / 75%

5. Energy Efficiency Initiative: HVAC Replacement for Sustainable Operations Las Vegas Area Council, Inc., Boy Scouts of America W. Todd Walter

- CDBG Activity: Community Infrastructure/Facility
- CDBG National Objective: Primarily benefit low and moderate-income households
- **Project Goals:** Replace the aging HVAC systems at the Las Vegas Area Council Resource Center which aligns closely with Clark County's values and goals, particularly those focused on creating a healthy and sustainable natural and built environment.
 - Alignment with Core Value 3: A Healthy and Sustainable Natural and Built Environment Goal 3.6: Incorporate Enhanced Sustainability and Resilience Practices

This transformation will optimize energy use, which is vital for creating sustainable structures.

- **Project Goals:** Overall, this Chromebook distribution initiative for SNRHA residents seeking sustainable employment addresses immediate needs and reinforces Clark County's commitment to building an equitable, connected, and resilient community for all.

Chromebooks Distribution Initiative for Southern Nevada Regional Housing Authority Residents (SNRHA) The Las Vegas Clark County Library District

- Beneficiaries: Adults residing in SNRHA's public and affordable housing communities
- Estimated Number Served: 150 Chromebooks to residents seeking employment
- Location: Public housing communities are located throughout Clark County. SNRHA's main office is at 340 N. 11th Street in Las Vegas. The Library District Service Center is at 7060 W. Windmill Lane in Las Vegas.
- **Project Timeline:** The Library District estimates completing the distribution of Chromebooks within 60 days after receiving notification that it has been awarded.
- CDBG Request: The District is requesting \$43,000, which is 100% of the total project budget.

7. Teen & Young Adult Independent Living Program Olive Crest Alyssa Dennison-GlasGow

- CDBG Activity: Public Service
- CDBG National Objectives: Primarily benefit low and moderateincome households
- Project Goals: Diverse housing options, access to health and social services, workforce development, economic mobility and opportunity.

- Beneficiaries/Estimated Number Served: Olive Crest's Teen & Young Adult Independent Living Program provides 16 former foster youth with the stability, guidance, and resources needed to transition successfully into adulthood




10. One Extended Family The Foundation Christian Center





 - Lower operating costs and improve financial sustainability
 - Improve long-term energy reliability of HSR
 - Improve overall living conditions for clients and work environment/conditions for employees
 - Provide life-saving healthcare to men recovering from substance use disorders and co-occurring mental health conditions

Harris Springs Ranch Solar Conversion WestCare

- Beneficiaries:
 - Low-moderately / Low-income persons
 - Persons experiencing homelessness
 - Person with disabilities
 - Men battling SUD and co-occurring mental health conditions
- Project Timeline: WestCare anticipates project completion by June 30, 2026
 - Once funding is approved WestCare will immediately begin obtaining the necessary permits to begin construction
 - After receiving the necessary permits, site preparation will begin
 - Contractors then begin installing solar panels, battery energy storage systems, inverters, and supporting electrical infrastructure to maintain uninterrupted, sustainable power for HSR's 24/7 operation
- CDBG Request: \$1,000,000 (100%)

12. Torrey Pines Early Learning Village YMCA of Southern Nevada

- CDBG Activity: Community Infrastructure/Facility
- CDBG National Objectives and Project Goas:
 - Meet an urgent community need
