SCOPE OF WORK: The "Project" of which the "Work" of the Contract is a part titled Maslow Park Fire Station 62 and is located at 4900 East Lana Drive, Las Vegas, Nevada 89121. The "Work" is described in the Project Drawings and Divisions 01 through 34 of the Project Manual.

A new 11,055 SF fire station complete with (3) bays and staff area for proper operations; Off-site construction, signalization; a new (approximately) 500 SF multi-use conference room complete with signage, parking area, landscaping and appurtenances including utility pioneering and on-site work; includes coordination Locution Systems as required for fire station operations; includes coordination with Owner vendors (installation); flag pole, digital sign, perimeter fencing, trash enclosure, mechanical yard and tank enclosure.

Work hours: The General Contractor will perform construction activities during the following times: Sunday through Saturday starting from 7:00 am to 6:00 pm. All dates and times will be outlined in the Project Schedule as required per Section 01 32 16 – Progress Schedule. Contractor will notify Owner's Representative when changes to the submitted working days/hours are deemed necessary.
