SCOPE OF WORK: This project involves the removal and replacement of existing lighting systems at the Clark County Shooting Complex. The scope of work is divided into two key areas:

1. Shooting Ranges – Upgrade sports field lighting with Musco Light-Structure System Retrofit LED fixtures, Owner Furnished Contractor Installed (OFCI).
2. Outdoor Parking, Pathway, and Building Areas – Remove existing lighting fixtures and procure and install new LED fixtures, Contractor Furnished Contractor Installed (CFCI).

ESTIMATED COST: \$1,481,820 - \$1,770,256.
