WAIVER OF DEVELOPMENT STANDARDS to increase wall height. DESIGN REVIEWS for the following: 1) a proposed single family residential development; and 2) increased finished grade on 26.8 acres. Generally located on the north side of Boulder Lane, 1,350 feet east of MacFarland Avenue within Indian Springs (description on file).
