V. Informational Items

RECEIVED APR 12 2019 OUNTY CLERK Receive a report from Metro regarding activity and statistics during the past month and other area crime concerns (for discussion only). Metro Sergeant Jeff Dean reported that a F250 truck was burglarized and vandalized while parked at the MSVFD last weekend. It did not belong to anyone in the community. If anyone knows of anything regarding this crime, please contact Metro.

- 2. Receive a report from Clark County Administrative Services regarding final Capital Improvement request list and any other updates from Clark County (for discussion only). Approved improvement requests will be announced next August, 2019. Any requests made on behalf of the MSVFD will be presented as soon as they have been approved.
- 3. Representatives from NDOT will present updates and respond to questions regarding the SR 160 road project. (for discussion only). Don Christiansen was present to discuss the roadwork. There will be blasting, 3-4 days, next week. The last blast will be on 12-21, then no further blasting until after the new year. They are currently trenching for storm drains. First of the year they will be working on the roadway towards Pahrump. There was an issue of a barrier approximately 1,000 feet east of Pinon that was hanging out into the lane. Don said he would look into this. The temporary signal does have a sensor which picks up automobiles coming out from the Benedict and Pinon areas. This sensor turns red when a vehicle is detected; however, it picks up trucks better than cars. It was reiterated that no rumble strips will be permanently placed along the roadway through the community pass. There will be landscaping and decorative signage/ironwork placed upon the roadway along the community pass. The speed limit, once construction is completed, will be 45mph along the community pass. Lighting, as stated in previous meetings, will be amber, down pointing LED. There will be 4 street lights at the intersection of Williams Ranch Road and SR160, 3 at the MSVFD and SR160 intersection, and 4 at the Pinon and SR160 intersection.

USE PERMIT for live entertainment.

WAIVERS OF <u>DEVELOPMENT STANDARDS</u> for the following: 1) reduce the interior or side setback for an accessory structure (stage); and 2) reduce the minimum separation from a residential use for live entertainment conducted outdoors.

<u>DESIGN REVIEW</u> for an outdoor stage in conjunction with an alcohol, on-premises consumption (tavern) establishment on 2.8 acres in an R-U (Rural Open Land) Zone in the Spring Mountain Overlay District. There were many residents present that showed great concern with allowing any amplified live music inside the Mountain Springs Saloon, let alone any outdoor live amplified music. Chase Bustos was present with his representing attorney, Jay Brown. Also present was Chase's father, Augie Bustos. The general consensus was that live outdoor amplified music travels up and across the mountain which hinders the solitude, peaceful and serene mountain community. As things stand now, the current live amplified music indoors can be heard by those living on the north side of SR160, on Benedict Drive, as well as on the south side of SR160 up along the Matre Mae and Pinon neighbors. There were three renters that live in the immediate area of the saloon that claim to hear no music. All residents that were present argued against any live outdoor amplified music. The main concerns are that the music will be too loud; no sound decibel monitoring & that the shut off times will be abused. A suggestion was made for designing the stage to be more encompassing. The final decision (28 for: 8 against) was as follows:

INDOORS: Live amplified music Saturday and Sunday, 12:00 p.m. to 8:00 p.m., and the

second Friday of the month (biker day), 4:00 p.m. to 8:00 p.m.

OUTDOORS: Sunday 1:00 p.m. to 5:00 p.m., and second Friday of the month (biker day),

4:00 p.m. to 8:00 p.m.

This is for 90 days only, at which time there will be another public review.
