Post Construction Permits Building Permit Guide

Part I. General Information

Projects that are built without a permit shall require the issuance of the appropriate permit(s) and the proper inspections to be considered code compliant.

Part II. Plan Submittal

Plans and calculations, as needed, shall be submitted to the Permit Application Center. Dependent upon the structure(s) built, reference the appropriate permit guide(s).

Part III. Plans Examination

Plans and calculations shall be reviewed by Plans Examination to determine compliance to the International Building Code (IBC), current adopted edition. The plans and calculations must be approved by Clark County prior to permit issuance.

NOTE: Resorts covered under Clark County Building Administrative Code section 22.02.055(B) may require compliance to code of construction, as defined in departmental Policy and Procedure DS-PP-119.

Part IV. Special Inspection

If special inspections are required in accordance with Chapter 17 of the IBC, then a registered design professional shall submit a work plan in accordance with Clark County Technical Guideline 50 Appendix C. The work plan shall outline how the special inspections are to be performed on the as-built structure. The work plan shall be approved by Clark County prior to the issuance of a building permit.

Part V. Structural Inspections

There may be some structural building inspections that are not considered special inspections that will have to be performed on the as-built structures. An example of this would be a foundation inspection. All required structural building inspections for work that is covered-up in the as-built structure shall be included in the work plan.

Part VI. Building Inspections

Required building inspections such as framing, lath, electrical, plumbing, and mechanical will have to be performed on the as-built structure. Please contact the Building Inspections Manager or the Inspections Area Supervisor to set-up a meeting to determine the inspection requirements. This meeting should occur prior to building permit issuance.
