A. POLICY

Specific building elements, as defined within the procedures below, may be deferred for submittal from the time of the building permit application. The design of any structural members that provide stability to the building, including lateral force resisting systems and their connections, are not permitted to be deferred, unless specifically approved by the Building Official. Deferred submittals are not allowed on standard plan submittals (residential or commercial).

B. PROCEDURE

- 1. Projects may have building elements identified as part of the original scope of work, but the specific details and complete design for that element may still be undetermined. These elements are usually designed by the manufacturer, specialty subcontractor, or a specialty architect or engineer.
- 2. If an applicant wishes to defer any scope of work for a building project, it must be clearly identified on the general note page, with a specific section named: "Deferred Submittals" and any deferred building element(s) shall be listed under that section.
- 3. These deferred building elements must be shown conceptually on the construction plans and must be included in the valuation of work for the building permit under review. The conceptual drawing for the building element must also indicate the intention to submit the detailed design at a later date.
- 4. The assigned plans examiner shall add the deferred submittal requirements on the Plans Exam tab in Accela identifying all building elements which will be submitted as a deferred design. A deferred submittal is treated as a revision and charged hourly plan review fees, once submitted.
- 5. Inspection staff shall include the hold point(s) as noted in the table below upon receipt of the deferred submittal report. The approved drawings must be available at the construction site for use by inspection personnel. The plans examiner is to clear the hold point(s) upon approving the deferred submittal.
