Notes & Highlights

- ² - Private ambulances response zones include: Zones 1 & 2 (AMR), Zones 5 & 6 (MedicWest), and Zones 7 & 8 (Community). Zone 8 response area was established on 2/1/2022.
- ³ - Permits issued include construction, annual, renewal and temporary permits.
