## COMMISSION SUPPORTS PRIVATELY FUNDED HIGH SPEED RAIL PROJECT



Plans for a high-speed train linking Las Vegas and Southern California took another step forward in July when the County Commission unanimously approved state findings related to financing for the project.

"We have been working to achieve high-speed rail between Clark County and Southern California for decades and today's approval marks a significant milestone in that long process," said Commissioner Michael Naft, whose district includes the land for the future rail line and the Las Vegas train station. "This project does not use one penny of taxpayer money, has a track record of success, and will put 10,000 Nevadans to work in a time when we need jobs and economic investment."

When finished, we expect this new train will remove 3 million vehicles from our roads every year, which will lower CO2 emissions by 100,000 tons annually.

## **STADIUM REACHES SUBSTANTIAL COMPLETION**

Clark County issued a Certificate of Occupancy on Allegiant Stadium, the new home of the NFL's Las Vegas Raiders and notably the largest entertainment venue in Las Vegas. The joint venture team wrapped up the \$1.97 billion facility on July 30, marking the end of a successful 31-month-long construction schedule, a mere 40 months after the NFL's approval of the Raiders move to Las Vegas.

The 1.8 million-square-foot stadium will also host UNLV Football and a variety of other sporting and non-sporting events. The facility features 65,000 seats, a retractable natural turf field, large operable walls that open to spectacular views of the Las Vegas Strip, a translucent roof, and a variety of premium spaces.

"Allegiant Stadium was built by thousands of hardworking men and women, and I am looking forward to a time when we can enjoy this incredible facility together," Clark County Commissioner Michael Naft said. "The new home of the Las Vegas Raiders is befitting of all that Southern Nevada stands for: strength, perseverance and style."

Visually inspired by the sleek and gradual curves of a futuristic luxury vehicle, Allegiant Stadium is unlike any other venue, making it an architectural and engineering marvel. One unique feature of the domed stadium includes the cable net truss system used for the roof. The seven-acre ETFE roof is suspended by 100 stainless steel cables that creates the light-weight roof structure diaphragm.

Design-Build delivery was instrumental to the project's success and technology drove enhanced decision-making at all facets of the project, ultimately reducing the time and cost of construction.

# **CARES HOUSING ASSISTANCE PROGRAM**

The County is launching a new program this week to help residents facing financial hardship because of the coronavirus and related shutdowns pay their rent, mortgage and utility bills. Information about the CARES Housing Assistance Program (CHAP) is available at https://helphopehome.org/clark-county-careshousing-assistance-program/. There are income and other limits on who may qualify for the assistance, which is funded by the federal CARES Act. The County is partnering with 14 local nonprofits to help administer the program, which can pay rent, mortgage or utility bills in arrears back to March 1, 2020, as well as utility deposits, security deposits and emergency lodging. Payments are made directly to a landlord, mortgage company and/or utility company. The County has dedicated federal CARES funding in the amount of \$30 million to this program.
