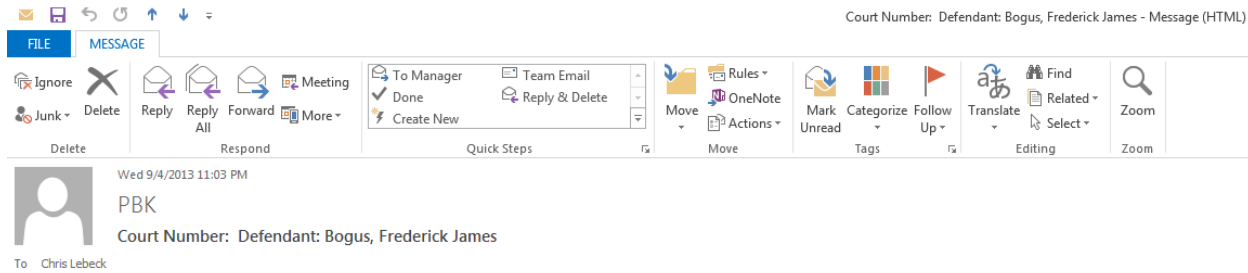


## eSubpoena

The police officer is notified of a new subpoena by email that has a link to the eSubpoena service website. The email received is completely customizable by the prosecutor's office. A sample one is below.

1. To view the Subpoena the officer clicks on the website link.

2. Log in with credentials provided.

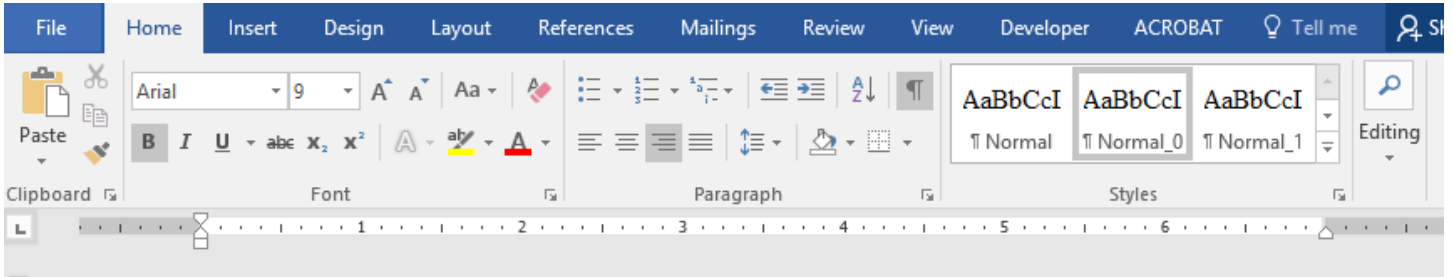
4. Click **Exit**, the subpoena has been delivered. Click **View**, on the website to view all active subpoenas.

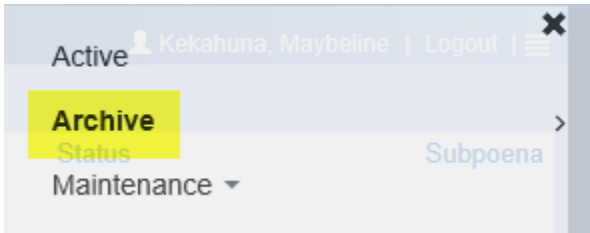
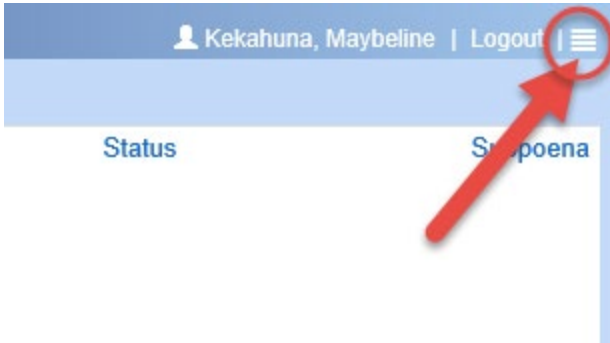

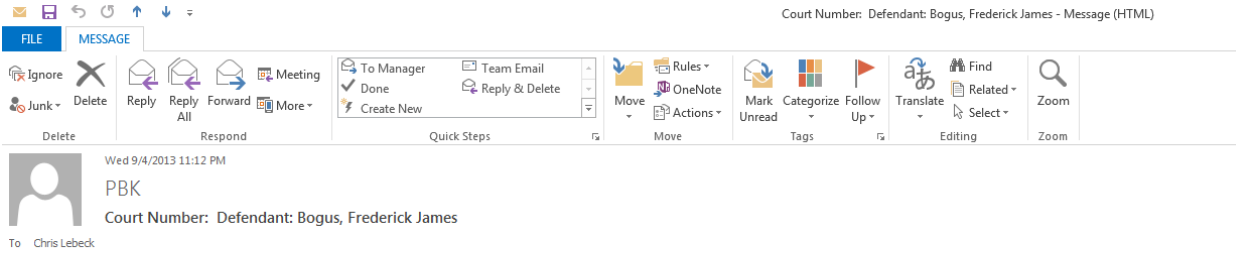

6. Besides receiving notification of subpoenas by email, officers will also receive notifications when their court dates are called off or cancelled. The format of the email is customizable to fit the needs of the prosecutor's office.
