



Limited License with the following CONDITIONS: 1. Maheer Faraj Hayawi voluntarily agrees to refrain from carrying a weapon on the licensed premises or have a weapon assessable at any time in the establishment during the one (1) year limited license period. 2. Maheer Faraj Hayawi shall refrain from contact with law enforcement for any firearm related matter. 3. Provide the Department of Business License proof of the completion of the regulatory compliance seminar or a space lease agreement with a licensed slot route operator; and 4. Must report any citations, arrests or violations of the law to the Department of Business License within twenty-four (24) hours. Any violation of these conditions may result in the automatic revocation of the license.
