Statement by the Director of Business License

All licenses, permits or findings of suitability are conditioned upon compliance with all provisions of Zoning, Building, Fire or other Codes, State Gaming Statutes and regulations as applicable, Health Department regulations and the payment of Business License fees and investigation fees, as required by Ordinance or Regulation, unless specifically waived in code.

Licenses approved by the Director may not be activated until a final inspection and sign-off are received from an Agent of the Department of Business License.

Any Liquor License not placed into operation within sixty (60) days of the Director approval is automatically revoked.

The Director **APPROVE** for a 6-month extension (first) of the Preliminary Determination of Location Suitability for a Tavern and Class A Gaming License in conjunction with restaurant with the following conditions:

1. A tavern liquor license is contingent upon the surveyor's diagram being correct in its distance measurement from main entry door of the prospective tavern to the main entry door of the existing tavern depicted on the diagram.
2. A tavern license shall not be issued unless the main entry door of the prospective tavern be less than 2,000-foot radius from the main entry door of the nearest existing tavern.
3. No tavern liquor license shall be granted to any establishment located within one thousand five hundred feet of any entry to school property (gate, door, driveway, etc.), any place wherein a school is conducted or within one thousand five hundred feet of any church.
