**Any Liquor License not placed into operation within sixty (60) days of the Director approval is automatically revoked.**





The Director **APPROVED** the application for a second 6-month extension of the Preliminary Determination of Location Suitability for a Tavern Liquor License with Class A Gaming to expire **February 28, 2023, with the following conditions:**

1. A tavern liquor license is contingent upon the surveyor's diagram being correct in its distance measurement from main entry door of the prospective tavern to the main entry door of the existing tavern depicted on the diagram.
2. A tavern license shall not be issued unless the main entry door of the prospective tavern be not less than a 2,000-foot radius from the main entry door of the nearest existing tavern or non-conforming tavern location.
3. No tavern liquor license shall be granted to any establishment located within one thousand five hundred feet of any entry onto school property (gate, door, driveway, etc.), any place wherein a school is conducted, or within one thousand five hundred feet of any church, and the outside edge of children's public playgrounds.
