2024 Presidential Preference Primary (PPP) General Information and Candidates

On February 6, 2024, Nevada will have its first ever Presidential Preference Primary as part of the nationwide process to choose presidential candidates for the November General Election ballot. Early Voting will be seven days from January 27 to February 2, 2024. Per NRS 298.600-720, added in 2021, the Clark County Election Department will conduct the PPP. Like all elections in Nevada, it will be an all-mail ballot election. In-person voting options will still be available during Early Voting and on Election Day.

Only voters registered as Democratic or Republican may vote in this election. All active Clark County voters regardless of party affiliation will receive a sample ballot. However, only active voters registered as Democratic or Republican will receive a mail ballot or may vote in-person (instead of by mail) on a voting machine at any Early Voting site or Election Day vote center.

Register or Update Your Registration

Voting will be easier and faster the sooner you register to vote or make updates to your existing registration. Avoid surprises by doing what you need to do as far in advance as possible. See the Presidential Preference Primary (PPP) registration-related dates on the next page for details about how voting and registration options may change the later you wait.

Check your voter registration (name, address, political party, etc.) online to ensure it is accurate and up-to-date by logging in to Registered Voter Services at www.clarkcountynv.gov/government/departments/elections/voter_services.php. If you need to register to vote or make changes to your existing registration, you may do so online at <https://registertovote.nv.gov>. Dates for the 2024 Presidential Preference Primary (PPP) February 6 Is Election Day January 27–February 2 Is Early Voting

1/9/24, Tue.: Deadline for Standard Registration for the PPP

The fourth Tuesday before Election Day is the last day to register to vote or to update your existing registration without having to do so on the Secretary of State's website or through the [same-day registration](#) process.

1/10-23, Wed.-Tue.: Online Only Extended Registration and Updates (14 Days)

During this time period, you may register to vote or update your existing registration **ONLY** online on the Secretary of State's website at <https://registertovote.nv.gov>. You will still automatically be sent a mail ballot. You may also opt to vote a [regular ballot in-person](#) (instead of by mail) on a voting machine at any Early Voting site or Election Day Vote Center within the County.

1/18/24, Thu.: No Mailing of Sample Ballots to New or Updated Voters

If you register to vote or update your existing registration on or after this date (less than 20 days before the PPP), you will not receive an applicable sample ballot for the PPP.

1/24-2/6/24, Wed.-Tue.: Online Same-Day Registration and Updates (14 Days), Only In-Person Voting Allowed

Register to vote or update your existing registration online on the Nevada Secretary of State's website (<https://registertovote.nv.gov>), up to and including Election Day. You will NOT be mailed a sample ballot for the PPP for the new or updated registration, and you may NOT vote by mail. You may only vote in person on a voting machine at any Early Voting site or Election Day Vote Center of your choice within the County. New registrants may only vote a [provisional ballot](#).

1/27/-2/2/24, Sat.-Fri.: PPP Early Voting, (7 days)

Any voter registered in Clark County (including those who received a mail ballot and instead wish to [vote in-person](#) on a voting machine) may vote at any Early Voting site within the County. Hours and days vary by location. In-person [same-day voter registration](#) (only [provisional ballot](#) voting allowed) and [updates](#) of existing registration will be available.

2/6/24, 7am-7pm, Tue.: PPP Election Day for Major Party Candidates

Any voter registered in Clark County as Democratic or Republican (including those who received a mail ballot and instead wish to [vote in-person](#) on a voting machine) may vote at any Election Day Vote Center within the County. In-person [same-day voter registration](#) (only [provisional ballot](#) voting allowed) and [updates](#) of existing registration will be available.
