**Same Day Registration Period\*** – Voters that register during this period will be required to present an unexpired Nevada Driver's License or Identification Card issued by the DMV. See our website for more information regarding Same Day Registration requirements at <u>www.clarkcountynv.gov/vote</u> or your sample ballot. Same Day Registration will be available at all Clark County polling places.

## **U. S. Armed Force Members and Family FPCA Deadline**

## Tuesday, November 3, 2020 – 7:00 p.m.

Nevada's Effective Absentee System for Elections, or EASE, is an online application that seamlessly integrates voter registration and electronic ballot delivery and marking. EASE is available to members of the United States Armed Forces, their spouses and dependents, and Nevada voters who reside outside of the country. For more information you can go to

the Federal Voting Assistance Program site at https://www.fvap.gov/. FPCA voters must provide the following information in order for the request to be processed.

What we need in order to process the FPCA:

- Classification (per block -1 of the FPCA)
- Address last domiciled before leaving the US (per block 2 of the FPCA)
- Where you are now (per block 3 of the FPCA)
- Ballot receipt preference (per block 5 of the FPCA)
- Signature (per block 7 of the FPCA)





MAIL BALLOT DROP OFF LOCATIONS – ALL EARLY VOTING AND ELECTION DAY SITES - Locations will be included in the mail ballot packet that will be mailed to each active voter in addition to the sample ballot. 
# EARLY VOTING AND ELECTION DAY FOR THE NOVEMBER 3, 2020 GENERAL ELECTION

**ELECTION DAY** is Tuesday, November 3, 2020 from 7am to 7pm. All election day locations serve as drop off locations for further convenience.

Digitally preview your mail and manage your packages scheduled to arrive soon! Informed Delivery allows you to view greyscale images of the exterior, address side of letter-sized mailpieces and track packages in one convenient location. You can check the delivery of your mail ballot with this easy to use service.
