Candidate Filing (Judicial and Non-Judicial): Period during which judicial and non-judicial candidates may file to run for office in 2022. ([NRS 293.177\(1\)\(b\)](#) and [AB1](#) of the Nov. 2021 Special Legislative Session)
No Appointments.

Last Day to Withdraw or Rescind Withdrawal of Candidacy (Judicial and Non-Judicial): Last day judicial and non-judicial candidates may withdraw their candidacy or rescind withdrawal of candidacy. ([NRS 293.202](#))

2022 PRIMARY ELECTION-COUNTY & CITY ELECTIONS

All voters registered in Clark County, NV, may vote from 7am to 7pm on Election Day at any Vote Center of their choice in Clark County, including those who received a mail ballot and did not yet return it.

A Primary Election is a preliminary (nominating) election to select, when necessary, Democratic, Republican, and nonpartisan candidates who will run in the General Election contests (except candidates for special district offices because they will only appear in the General Election). The direct vote of the people selects the candidates, rather than votes of convention delegates. In State/Federal Elections, Nevada has CLOSED Primary Elections. (NRS 293.257) The Primary Election must be held on the second Tuesday in June of each even-numbered year. (NRS 293.175(1))

April 15 Friday **Opt-Out Deadline for Mail Ballots:** The last day for the Election Department to RECEIVE WRITTEN OR ONLINE requests to not receive a mail ballot is 60 days before Election Day. (Sections 3 and 51 of AB321 of the 2021 Legislative Session)

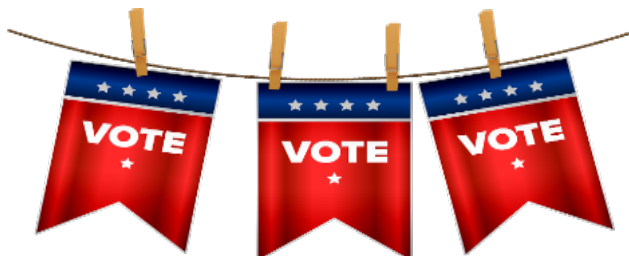
April 30 Saturday **Deadline for the Start of Mailing of Military and Overseas Ballots:** Mail ballots must be ready for distribution to military and overseas voters no later than 45 days before Election Day. (NRS 293D.320)

May 5 Thursday **Deadline for the Start of Mailing of Out-of-State Ballots:** Mail ballots must be ready for distribution to out-of-state voters no later than 40 days before Election Day. (NRS 293.309(2)(a)(2))

May 17 Tuesday **Deadline for Standard Registration:** The last day to register to vote or to update your existing registration without having to do so on the Secretary of State's website is the fourth Tuesday before Election Day. (NRS 293.560)

May 18-31 Wednesday-Tuesday **Online Extended Registration and Updates (14 Days):** Register to vote or update your existing registration online ONLY on the Secretary of State's website at www.RegistertoVoteNV.gov.

May 25, Wednesday **Deadline for the Start of Mailing of In-State Ballots:** Mail ballots must be ready for distribution to in-state voters no later than 20 days before Election Day. (NRS 293.309(2)(a)(1))

Early Voting (14 Days): Any voter registered in Clark County (including those who received a mail ballot) may vote at any early voting site within the County. Hours and days vary by location. (NRS 293.3568)

-In-Person Same-Day Registration and Updates at Early Voting Sites (14 Days): Register to vote or update your existing registration in-person at any early voting site of your choice. You must immediately vote at that site. *Requirements only for same-day registration (not updates) are:

*You may only vote a provisional ballot with all offices and contests that would be on a regular ballot at the site where you registered.

*You must show a current and valid (unexpired with current Clark County, NV, residential address) **NEVADA** driver's license, **NEVADA** DMV issued state identification card, **NEVADA** DMV Interim Document, or Tribal ID.

*Be prepared to also show additional proof of residency **IF** none of the above have your current Clark County, NV, residential address on them (provisions are available for homeless persons). Proof of residency supplements the above-required items and does NOT substitute for them.

*Your provisional ballot will be counted only after verification of your registration data and that you did not cast more than one ballot in the election. (NRS 293.5832, 293.5842, and 293.5852)

Online Same-Day Registration and Updates (14 Days): Register to vote or update your existing registration online **ONLY** on the Secretary of State's website, up to and including Election Day. You will NOT be mailed a sample ballot for the current election for the new or updated registration and you may NOT vote by mail. You may only vote in person at any early voting site or Election Day vote center of your choice.

*Requirements only for same-day registration (not updates) are:

*You may only vote a provisional ballot with all offices and contests that would be on a regular ballot at an in-person voting site.

*At the voting site, you must show a current and valid (unexpired with current Clark County, NV, residential address) **NEVADA** driver's license, **NEVADA** DMV issued state identification card, **NEVADA** DMV Interim Document, or Tribal ID.

*Be prepared to also show additional proof of residency **IF** none of the above have your current Clark County, NV, residential address on them (provisions are available for homeless persons). Proof of residency supplements the above-required items and does NOT substitute for them.

*Your provisional ballot will be counted only after verification of your registration data and that you did not cast more than one ballot in the election. (Sections 42.5, 43, and 80.5 of AB321 of the 2021 Legislative Session, which revise NRS 293.560, 293.5837, 293C.527)

Postmark Deadline: Voted mail ballots returned through the post office must be postmarked no later than June 14th, Election Day. (Sections 8 and 56 of AB321 of the 2021 Legislative Session)

-In-Person Same-Day Registration and Updates on Election Day:
Register and vote or update your existing registration in-person at any Election Day vote center of your choice.

Requirements only for same-day registration (not updates) are:

*You may only vote a provisional ballot with all offices and contests that would be on a regular ballot at the site where you registered.

*You must show a current and valid (unexpired with current Clark County, NV, residential address) **NEVADA** driver's license, **NEVADA** DMV issued state identification card, **NEVADA** DMV Interim Document, or Tribal ID.

*Be prepared to also show additional proof of residency **IF** none of the above have your current Clark County, NV, residential address on them (provisions are available for homeless persons). Proof of residency supplements mentioned above are required items and does NOT substitute for them.

*Your provisional ballot will be counted only after verification of your registration data and that you did not cast more than one ballot in the election. (NRS 293.5832, 293.5847, and 293.5852)

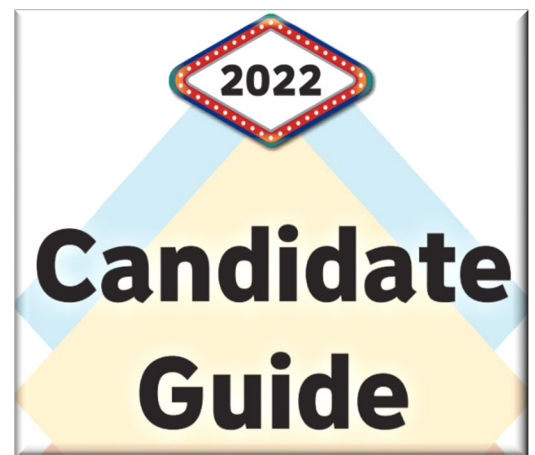
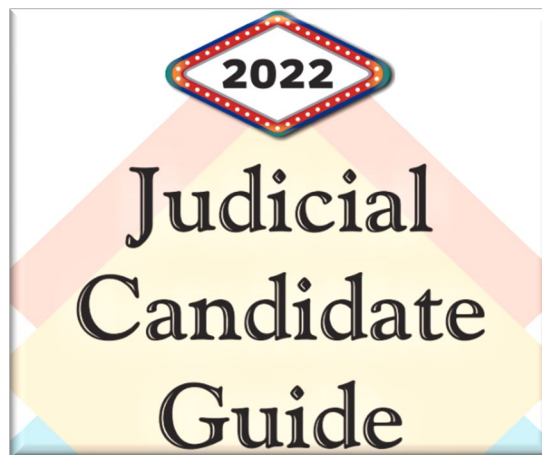

Deadline for Receiving Voted Mail Ballots Returned Through the Post Office: By 5pm on the fourth day after Election Day, the Election Department must receive your voted mail ballot postmarked no later than June 14th, Election Day. (Sections 8 and 56 of AB321 of the 2021 Legislative Session)

Deadline for Curing Mail Ballot Signature Issues:
Must provide a signature confirmation or an actual signature, as applicable by 5pm on the sixth day after Election Day.

NEW: CHANGES TO ELECTIONS AFTER THE 81st LEGISLATIVE SESSION

ASSEMBLY BILL 321 (AB321)

All Mail Ballot Elections: Starting in 2022, Nevada will have all-mail ballot elections. All voters who are registered to vote no later than 14 days before Election Day will receive a mail ballot whether or not they requested one, unless they opt-out.

Opt-Out: To opt out, you must submit a *written or online* “Mail Ballot Preference Form” to request that you not receive a mail ballot. The Nevada Secretary of State will provide the online option and the Election Department will immediately receive the request. The Election Department must receive all requests no later than 60 days before Election Day. You still have the option to vote in person on a voting machine at any one of the many convenient early voting sites or Election Day vote centers, even if you receive a mail ballot.

Mail Ballot Drop Boxes: The Election Department will provide secure mail ballot drop boxes that are easily accessible, conveniently located, and widely available, including at all



early voting sites and all Election Day vote centers. It will be a felony for anyone other than the Election Department to provide these boxes. Drop box locations and hours will be in your mail ballot packet, in your sample ballot, and

online at www.ClarkCountyNV.gov/vote.

Mail Ballot Postmark and Receiving Deadlines: Voted mail ballots sent through the Post Office must be: (1) Mailed in the postage-paid return envelope provided specifically for you, showing your name and address, and you must also sign the outside of that envelope before mailing it (*do not put your ballot in another voter's return envelope*); (2) Postmarked on or before Election Day; and (3) Received by the Election Department on or before 5:00 p.m. on the fourth day after Election Day.



Mail Ballot Signatures: Your signature on the outside of your mail ballot return envelope may be reviewed electronically, manually, or both. Electronic signature verification devices will be tested for accuracy before an election and audited daily during the processing of ballots. If an issue arises with your signature, the Election Department will notify you using the contact information in your voter registration.

If you need to “cure” your signature by providing an actual signature or a signature confirmation, you must do so by the sixth day after Election Day. At least once per year, all staff who administer elections must complete a forensic signature verification class approved by the Nevada Secretary of State.

Same-Day Registration Online (SDRO) Has Been Extended: Starting in 2022, you may register to vote online after the standard close of registration up to and including Election Day. SDRO voters may only cast a provisional ballot in person at a voting site (mail ballot voting is not allowed). Any voter with a current and valid Nevada driver's license or ID can register or update their registration record online at www.RegistertoVoteNV.gov.

Registration and Death Records - Secretary of State and Vital Statistics Cooperation:

The Nevada Secretary of State is authorized to enter into a cooperative agreement with the State Registrar of Vital Statistics to match statewide voter registration information with Vital Statistics records concerning deaths at least once a month to maintain the statewide voter registration list.

ASSEMBLY BILL 121 (AB121)

Provisions for Voters with Disabilities Expanded Registration and Voting Options:



The Nevada Secretary of State’s system of approved electronic transmission established for certain uniformed military and overseas voters may be used by a person with a disability to register to vote and also by a registered voter with a disability to cast a mail ballot. ASSEMBLY BILL 126 (AB126)



A Presidential Preference Primary (PPP) replaces Major Party

Caucuses: Starting in 2024, Nevada will have a Presidential Preference Primary (PPP) instead of caucuses to determine the preferences of registered Democratic and Republican voters for their major party’s nominee for U.S. President from among multiple candidates in their party. You may only vote for candidates from your own party (the party you specified on your voter registration application). Minor parties will not participate in the PPP and their candidates will go directly to the General Election ballot.

ASSEMBLY BILL 422 (AB422)



Centralized State Level Voter Registration System:

The Nevada Secretary of State must establish and maintain a centralized, top-down voter registration database for collecting and storing registration information from all counties. All counties must use the database to collect and maintain all voter registration information. The database will be used to create an official statewide voter list. The Secretary of State must prepare a semiannual report, from January 1, 2022, to January 1, 2024, detailing the progress of the implementation of the top-down database.

ASSEMBLY BILL 432 (AB432)



Expansion of Automatic Voter Registration (AVR) Agencies: Agencies that provide AVR as well as standard registration will include the Department of Motor Vehicles (DMV) plus:

The Department of Health and Human Services and the agencies it designates that are involved with Medicaid and/or the Silver State Health Insurance Exchange; and any other state agency, including the Executive Department or tribal agency that meets certain requirements and is approved by the Governor.

Informed Delivery allows you to view greyscale images of the exterior, address side of letter-sized mailpieces and track packages in one convenient location. COMMUNITY OUTREACH



It is the mission of the Clark County Election Department to build, strengthen, and expand outreach programs to create community networks that will participate in supporting new programs, promoting our current services, recruiting workers, and motivating electors to exercise their voting rights. In our efforts, we have collaborated with community based organizations that we seek to partner with in an effort to expand their ability to provide voter registration services and voter education services to citizens. The “Raise the Vote” partnership is designed to provide community organizations and businesses with an opportunity to participate in the electoral process in Clark County. At the same time, organizations can raise funds for the worthy causes in which they support. Each participating organization or business “adopts” a specific Vote Center, or several Vote Centers, for the election cycle by providing the personnel to staff that Vote Center. If the organization has a W-9 form on file with the IRS, the Election Department writes a check to the organization rather than pay each individual worker. Otherwise, volunteers will be paid

individually and can then donate their pay to their organization. By forming a partnership with the Election Department, funds raised are directed towards worthwhile causes and the voters are served by qualified workers at the polling places.
