

郵寄投票說明

第1步：使用黑色或藍色墨水筆，將您要選擇的候選人或選票問題旁邊的橢圓形塗滿。您無需為所有選舉項目投票。您所選的其他選舉項目仍將統計在內。如果您在某選舉項中填塗的候選人超過允許的數量，或者如果您在某一公投項目上同時填塗了「是」和「否」，您在這項競選或選票問題中的投票將不予統計，除非您按照說明進行了更正（下文中黃色部分為更正說明）。

第2步：選票填塗完畢後，將選票折疊放入保密封套中。

第3步：將保密封套（含有您已投票的選票）放入您的郵寄選票回郵信封中，該信封已付郵資，並且上面預先印有您的姓名和地址。如果您遺失或損壞了保密封套，請將折疊選票放在折疊後的普通紙張內。

第4步：將您的郵寄選票回郵信封密封，並在信封上簽名。我們將根據您存檔的簽名核對您在信封上提供的簽名。郵寄或投遞選票後，您將無法再更改投票。

請注意：如果您遺失或損壞了印有您姓名和地址的郵寄選票回郵信封（包含在您的郵寄選票包裹中），請立即致電 (702) 455-VOTE (8683) 查詢有關補發信封的資訊。

避免以下常見錯誤

對於選票，請勿：

- 在更正後填寫或簽署您的姓名或姓名首字母。
- 在橢圓形外做任何標記、寫註釋或圈出候選人姓名或問題選項。
- 損壞、修剪、剪切或撕毀選票的任何部分。
- 投票支持的候選人超過規定人數。

對於回郵信封，請勿：

- 將其他人的選票放入您的郵寄選票回郵信封內。
- 使用選舉部所提供郵寄選票回郵信封以外的任何其他信封郵寄或投遞您已投票的郵寄選票。

適用於協助另一位選民的要求

行動不便且年滿65歲或無法讀寫的選民的指示下，個人可以：(1) 代表該選民填塗選票並在信封上簽名；或 (2) 協助該選民填塗選票並在信封上簽名。

- 如果個人代表相應選民填塗選票並在信封上簽名，此人必須在其簽名旁註明已採取此行動（見示例 - 1）。
- 如果個人協助相應選民填塗選票並在信封上簽名，此人或相應選民必須在信封上提供其姓名、地址和簽名（見示例 - 2）。

示例 - 1

At the direction of a voter who has a physical disability, is at least 65 years of age or is unable to read or write, a person may mark the ballot and sign the envelope on behalf of the voter or assist the voter to mark the ballot and sign the envelope pursuant to this section. If a person marks the ballot and signs the envelope on behalf of a voter pursuant to this section, the person must indicate next to his or her signature that the mail ballot and envelope have been marked and signed on behalf of the voter. If a person assists a voter to mark the ballot and sign the envelope pursuant to this section, the person or the voter must include on the return envelope his or her name, address, and signature.

If you marked the ballot and/or will sign the envelope on behalf of the voter, put a check mark in the box to the left and sign your name (not the voter's name) inside the red outlined box below.

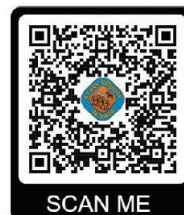
