Open Burning Stipulations (Air Quality Regulations, Section 42: "Open Burning"):

1. Notwithstanding Section 42.1, any burning permitted by this section must be controlled so that air contaminants being emitted do not create a public nuisance or traffic hazard(s).
2. Open burning shall be prohibited during air pollution episode conditions as defined in Section 6, "Emergency Episode Plan," of the Nevada State Implementation Plan.

When intentionally burning a structure, the NESHAP regulations will apply (40 CFR 61 Subpart M). In addition to the Open Burning Application and Notification, the following must also be submitted to Air Quality:

1. A thorough asbestos survey. (If the structure has been abated, submit the final clearance report. All asbestos-containing materials must be removed prior to burning, both friable and non-friable.)
2. A complete Clark County NESHAP Demolition Notification Form (DNF) submitted at least ten working days prior to demolition. One DNF must be submitted per structure, e.g. ten DNFs must be submitted for ten structures.
3. A complete Dust Control Operating Permit application if the structure is greater than or equal to 1,000 square feet, or greater than ¼ acre of soil will be disturbed.
