BACKGROUND:

The Clark County Desert Conservation Program has prepared the budget of expenditures for the Multiple Species Habitat Conservation Plan (Section 10) and for the Desert Tortoise Public Lands Conservation Fund (Section 7) for the biennium July 1, 2003 through June 30, 2005.

As required by the Clark County MSHCP, the Section 10 and Section 7 budgets have been reviewed and recommended by the MSHCP Implementation and Monitoring Committee, and have been reviewed and approved with conditions by the US Fish & Wildlife Service.

Section 10 expenditures are made from the mitigation fund generated by payments of land disturbance fees assessed for development of private lands and non-federal, non-exempt public lands within Clark County.

Section 7 expenditures are made from the mitigation fund generated by payments of land disturbance fees assessed for development of federal lands within Clark County.


