DESERT CONSERVATION PROGRAM

The Desert Conservation Program (DCP) manages Endangered Species Act compliance on behalf of Clark County and the cities of Boulder City, Henderson, Las Vegas, North Las Vegas, Mesquite and the Nevada Department of Transportation (NDOT) (collectively, the Permittees) through implementation of the Clark County Multiple Species Habitat Conservation Plan (MSHCP) and associated Section 10(a)(1)(B) incidental take permit. The MSHCP and permit allow private landowners to develop land in Clark County without the need for individual project-by-project consultations and negotiation with the U.S. Fish and Wildlife Service (USFWS) to comply with the Endangered Species Act, providing a streamlined process for compliance. In exchange for this permit, the DCP implements actions to mitigate impacts from development. These actions include research, acquisition of sensitive habitats, habitat restoration, public information and education, the Wild Desert Tortoise Assistance Line, and installation and maintenance of fencing along roadways to reduce tortoise mortality.

BOULDER CITY CONSERVATION EASEMENT (BCCE)

The incidental take permit requires the establishment of a conservation easement in the Eldorado Valley to be managed and protected for the benefit of the desert tortoise (*Gopherus agassizzi*) as partial mitigation for the take of desert tortoise and its habitat. The BCCE was established between Clark County and Boulder City in July of 1995 to fulfill this requirement.

ACTIVITIES FOR THIS QUARTER

- Continued processing a request from the City of Boulder City for a modification to the BCCE and easement agreement. The Board of County Commissioners will consider the boundary adjustment at an upcoming meeting.
- Provided oversight and project management for the interlocal agreement with Boulder City for Law Enforcement on the BCCE.
- Conducted twenty-three site visits to monitor use, disturbances, and related issues; to perform new signage installation, maintenance and upgrades; and for restoration planning and monitoring.
- Met with law enforcement during five site visits to plan patrols to cover areas where unauthorized uses were detected. A new Officer was assigned to patrol the BCCE.
- Installed two new signs on Route E to warn of flooding during and after rain events.

- Continued coordination with utility companies based in the Energy Zone in order to meet desert conservation and restoration goals.
- Continued ongoing mapping and assessment of unauthorized roads and other disturbances that will guide prioritization of restoration activities on the BCCE.
- Issued a Request for Quotes (RFQ) for cultural resource surveys of future restoration areas at the BCCE. The contract was awarded to SWCA Environmental Consultants, and the project is in progress.
- Issued an RFQ for round two of small mammal surveys at the BCCE. The contract was awarded to BEC Environmental, Inc., and the project is in progress.

RIPARIAN RESERVE UNITS

The incidental take permit stipulates that take of covered avian species is conditioned upon the acquisition of private lands in desert riparian habitats along the Muddy and Virgin rivers and the Meadow Valley wash. To comply with this permit condition, the DCP has acquired properties with riparian habitat along the Muddy and Virgin rivers in Clark County. These properties serve to mitigate impacts to covered species and conserve habitats and important connectivity corridors.

ACTIVITIES FOR THIS QUARTER

Muddy River Reserve Unit

- Planning efforts for the Southern Nevada Public Land Management Act (SNPLMA) Round 16 project to conduct habitat restoration on the Muddy River Reserve continue. A Request for Proposals (RFP) was prepared for completion of the restoration design. Proposals have been evaluated and a selection will go before the Board of County Commissioners in May 2019 for approval.
- The National Park Service's (NPS') Exotic Plant Management Team continues to conduct vegetation management and maintenance activities for enhancement of native riparian species.
- Restoration implementation is complete for the SNPLMA Round 14 project to conduct and enhance habitat restoration. The site was cleared of decadent vegetation and non-native species. NPS' Exotic Plant Management Team has planted previously collected native species and propagated species from their nursery. The site was completed and will be monitored throughout 2019.
- Eagle View Contractors continues ongoing maintenance of the Muddy River Reserve Unit.
- Monthly data collection on groundwater monitoring wells continues.

Virgin River Reserve Unit

- Continued photo-monitoring documentation of restored areas within the Mormon Mesa site.
- Planning efforts continue for the SNPLMA Round 15
 project to conduct 20 to 40 acres of habitat restoration
 on the Virgin River Reserve Unit. An Interlocal Agreement was approved November 6th for Nevada Division
 of Forestry (NDF) to masticate tamarisk on the Mormon
 Mesa and Riverside subunits. NDF has masticated four
 acres to date, and will continue this work in the fall.
- Participated in the Virgin River Coalition Steering Committee meeting.
- Analysis of Virgin River drone imagery was completed.

- NPS' Exotic Plant Management Team continues to conduct vegetation management and maintenance activities for enhancement of native riparian species.
- Additional surveys were conducted to provide an easement to Duane Magoon and Bunkerville Irrigation Company for a recently acquired parcel in Bunkerville.

Property Acquisition

- Continued coordination with Clark County Public Works Map Team to subdivide parcels identified for future acquisition.
- One parcel map has been completed and is currently being processed by the Clark County Assessor's Office.

ACTIVITIES FOR THIS QUARTER

Mojave Max Education Program

- Continued to provide oversight and project management for the contract with Get Outdoors Nevada for the Mojave Max Education Program.
- Twenty-Six Tortoise Talks were conducted during this reporting period.
- Six outreach events were conducted during this reporting period.
- Mojave Max emerged from brumation on March 30th at 1:28 pm; over 7,100 emergence contest guesses were received.



WILD DESERT TORTOISE ASSISTANCE

ACTIVITIES FOR THIS QUARTER

Wild Desert Tortoise Assistance Line

The 1995 Desert Conservation Plan and the 2001 MSHCP require that the DCP provide a hotline and pick up service to deal with wild desert tortoises which are displaced by development or appear to be in harm's way due to construction activity. The DCP operates the wild desert tortoise assistance line to meet this requirement.

- One call was received from the Wild Desert Tortoise Assistance Line during this reporting period.
- One wild desert tortoise was picked up during this reporting period; the tortoise is currently being held in quarantine pending a health assessment.

Desert Tortoise Fencing

• Continued planning activities for the construction of post-and-cable and desert tortoise fencing along the boundary of the Tule Springs Fossil Beds National Monument. This project will go out for bid once the Bureau of Land Management (BLM) has completed their cadastral survey of the monument.

OTHER WORK

ACTIVITIES FOR THIS QUARTER

• Through our Interlocal Agreement with the Nevada Division of Minerals, two bat compatible closures were installed on abandoned mine land hazards in the Valley of Fire area. These closures will ensure public safety while retaining the value of the associated wild-life habitat. Additional bat compatible closures will be installed at suitable locations in the coming quarters.

ADAPTIVE MANAGEMENT PROGRAM

As a requirement of the incidental take permit, the DCP is required to have an Adaptive Management Program (AMP) in order to gauge the effectiveness of existing conservation measures, propose alternative conservation measures as the need arises and to deal with changed or unforeseen circumstances.

ACTIVITIES FOR THIS QUARTER

- Held the guarterly Science Advisor meeting on February 12th.
- Attended the Desert Tortoise Council's annual symposium on February 21st 23rd and spoke on the work Clark County has done over the past year regarding tortoises.
- Attended the Desert Tortoise Management Oversight Group meeting on February 27th.
- Aided in training Great Basin Institute field crews involved in range wide monitoring on March 21st, 25th and 28th.

Permit Amendment

The DCP continues to pursue a major amendment to the MSHCP and incidental take permit. This amendment would allow for additional take authorization in Clark County while providing long-term assurances to the Clark County community for continued economic growth.

ACTIVITIES FOR THIS QUARTER

- Continued to coordinate with the USFWS to discuss issues related to the proposed amendment.
- Continued to work with Permittees on federal legislation that will support efforts to obtain an amended MSHCP; continued to coordinate with elected officials and other stakeholders on the development of the County lands bill; continued to meet monthly with the OHV Advisory Committee to discuss including protections for OHV recreation areas in the lands bill.
- Continued to administer a contract with Ebbin, Moser + Skaggs, LLP to provide legal counsel services in support of the permit amendment effort.
- Continued to secure necessary signatures to fully execute a Master Permit with NDF covering impacts to state-listed species. The Board of County Commissioners will consider approving the Master Permit at an upcoming meeting.
- Continued to administer a contract with WRA Environmental Consultants to assist with the preparation of documents and analyses that will support development of the MSHCP amendment. This quarter, the consultants continued developing methods for a habitat functionality analysis that will be used in conducting impact analyses to support the County's application for an amended incidental take permit.
- Executed an interlocal agreement with the University
 of Nevada, Reno for the development of an additional
 seventeen species distribution models. The models will
 be used in the development of the habitat functionality
 analysis and to estimate and track impacts to species. A
 kick-off meeting will be held in the next reporting period.

External Agency Coordination and Assistance

In order to keep well informed on the current and future land use impacts to Clark County, the DCP will review and potentially provide comments on issues relevant to Clark County. As a public agency, the DCP also provides data as requested to interested parties.

- Provided assistance to the Clark County Wetlands Park regarding Endangered Species Act compliance during long-term operations.
- Continued to coordinate with the Clark County Regional Flood Control District on the development of a new in-lieu fee mitigation program for projects that require a permit under Section 404 of the Clean Water Act.
- Provided interview assistance to the Department for recruitment purposes.



ADMINISTRATION AND FINANCE ACTIVITIES FOR THIS QUARTER

- Processed vendor payments 65 invoices: 61 accepted (94%), four rejected (6%).
- Fiscal Year (FY) 19 Budgets are being reconciled to prepare for end of year close. Expenditures continue to be monitored regularly to ensure appropriate spending and reporting occur. The process of developing FY19 estimates and FY20 budget is completed and submitted to the County Budget and Finance Office.
- Phase 1 of converting all existing credit card terminals to the new processor, Wells Fargo, has been completed. Phase 2 of converting the existing web and IVR systems has been completed. Phase 3 is in process to establish e-payments services for County departments that do not currently offer e-payments.

- Desert tortoise specialty license plate production is ongoing and plates are being distributed at Nevada Department of Motor Vehicles (DMVs).
- Oversight of the SNPLMA Round 8 Round 16 projects totaling \$8,117,515 continues in the County's financial system. The projects continue to be monitored for progress and reimbursement.
- Received reimbursement for SNPLMA projects: Round 15 - 3 draw downs (\$53,750.29).
- Completed the recruitment process to hire a new Environmental Specialist.

DCP staff is responsible for ensuring that land disturbed pursuant to the MSHCP is accounted for and monies are collected and deposited in the Section 10 special reserve fund established under the MSHCP. Below are charts which outline the total amount of fees collected and acres disturbed for the period 2001-2018.






