QUESTION 1: What did you accomplish during this reporting period?

How did these accomplishments help you reach the goal of your

project?

If relevant, what indicators or benchmarks were used to determine

your progress?

BEC conducted the habitat characterization methodology testing in early July, small mammal identification training and population monitoring methodology field testing early in September, and the first trapping session at one location in early September.

BEC conducted the habitat characterization methodology at the Clark County Wetlands Park in representative habitat for desert pocket mice.

BEC conducted small mammal species identification training in early September. Species identification training was conducted at the University of Las Vegas Nevada with preserved specimens of the species.

BEC conducted the population monitoring methodology field testing in early September. The field methodology testing was completed at the Riverside Parcel in the Virgin River Riparian Corridor during the first portion of the Trapping Session.

BEC conducted the first Trapping Session for the season at the Riverside Parcel in September. The trapping session captured 33 specimens of which 9 were the targeted species, desert pocket mouse.

BEC held a teleconference meeting with Jed Arnold (DCP) on September 26, 2024, to provide an update of the project, the results of the first trapping session, and potential challenges. BEC informed Arnold the second trapping session will be implemented as planned at the Bunkerville location.

QUESTION 2: What, if any, problems were encountered? Briefly describe those problems and the manner in which they were dealt.

On September 25, 2024, BEC was notified of herbivore repellent applications to the Bunkerville East parcel, of which one area of application was located near the proposed trapping grid. BEC has coordinated with Arnold and Caryn Wright (DCP) and intends to implement the trapping sessions as planned.

The first Trapping Session ended a day earlier due to unexpected predator interactions. Based on tracks seen near traps, a small canid had harassed the traps during the later portion of the trapping session, which resulted in a low success rate. BEC provided a summary of the situation in the meeting with Arnold, as mentioned above.

BEC completed all planned activities during this reporting quarter.

12% completion.

The team is evaluating options for future trapping approach to reduce encounters with predators and/or avoid low trapping success.
