

A Special Place in the Desert

The BCCE conserves 86,538 acres of Mojave Desert habitat primarily for the benefit of desert tortoises. However, upon your travel through the BCCE you may also come upon a wide assortment of desert wildlife including lizards, snakes, birds and a variety of plant species.

Watch Out for Sensitive Wildlife and Plants

The MSHCP includes 78 species as Covered Species, including the federally threatened desert tortoise (*Gopherus agassizii*). Another 103 species are listed as Evaluation Species and 51 as Watch List Species. MSHCP Covered, Evaluation, and Watch List species that may be found in the BCCE include:

The Clark County Desert Conservation Program manages Endangered Species Act compliance on behalf of the Permittees of the Multiple Species Habitat Conservation Plan (MSHCP). Balancing species protection with streamlined development, the MSHCP is a plan that describes the types of species conservation actions that the Permittees will carry out to offset the impacts of development within Clark County. The Desert Conservation Program carries out these mitigation actions on behalf of the MSHCP Permittees.

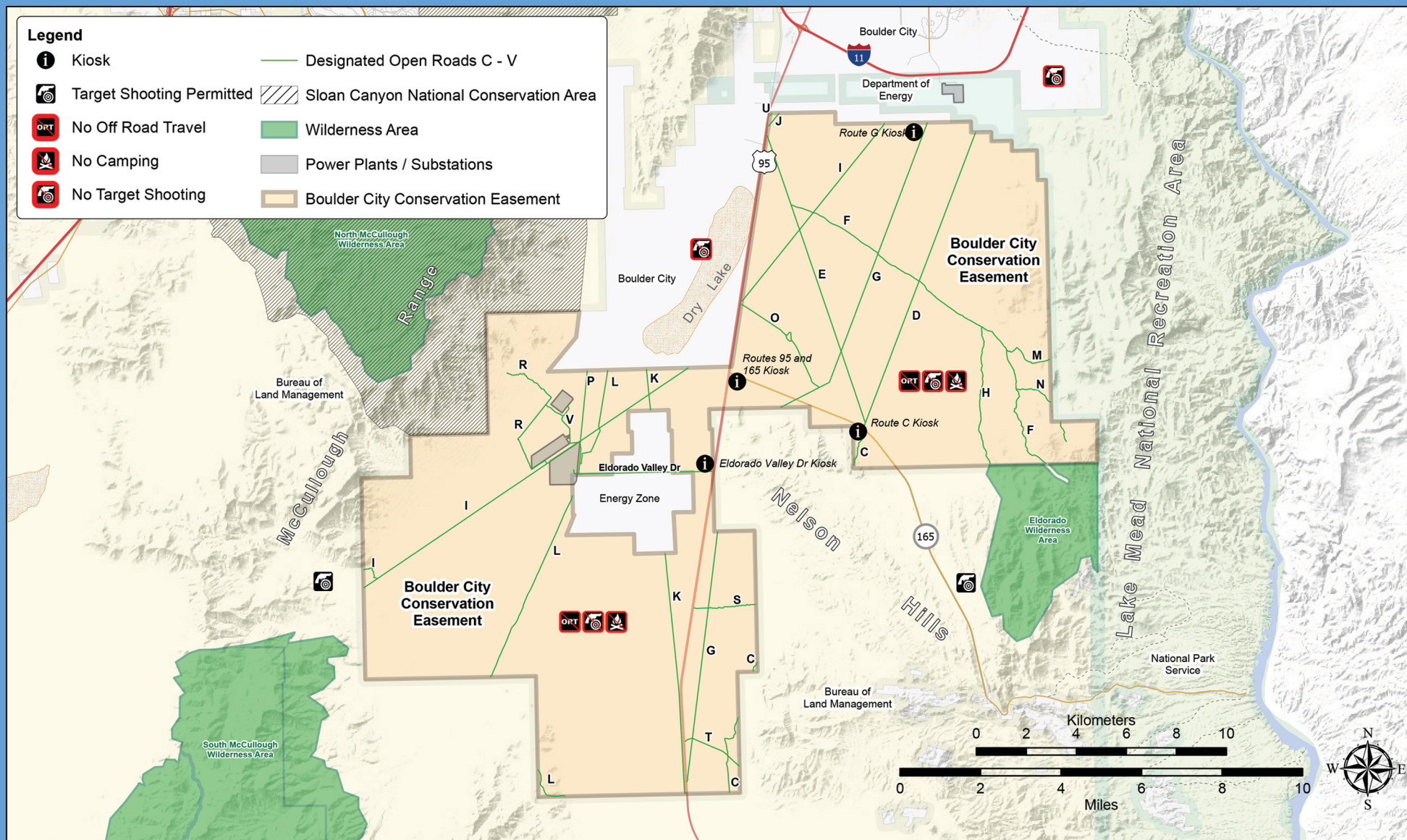

Protecting a Community Resource

The Boulder City Conservation Easement (BCCE) was established in 1995 by a partnership between Clark County and the City of Boulder City. Managed by the Clark County Desert Conservation Program, the BCCE was created to protect habitat for desert tortoises and other species covered by the Clark County Multiple Species Habitat Conservation Plan (MSHCP). This area serves as mitigation for impacts to desert tortoises resulting from private land development activities within the County. BCCE Rules of the Road

- Stay on marked, open roads

- Check for desert tortoises on the road and under your vehicle

- Release desert tortoises or other animals
- Collect plants or animals
- Shoot, hunt, or camp
- Conduct research without permission
