The work for the above referenced project has been completed. Below is a summary of project related information.

The purpose of the above referenced project was:

The Clark County DCP manages a system of Riparian Reserve Units and the Boulder City Conservation Easement (BCCE) for the benefit of MSHCP-covered species. The purpose of this project was to continue to build a dataset of presence/absence and relative abundance of avian species on the County's Reserve Units, with a focus on breeding bird point-count surveys and targeted surveys for southwestern willow flycatcher and yellow-billed cuckoos. This dataset serves as a quantitative means to evaluate the success of restoration and management efforts for supporting MSHCP-covered avian species.

The major accomplishments or findings of this project include:

Surveys were able to detect six of the eight bird species covered by the MSHCP and three evaluation species. The MSHCP covered and evaluation species were observed at all the County's properties. Flycatchers were confirmed to be breeding in Mormon Mesa Parcel 5-A, the first known successful breeding attempt at the location. In contrast, breeding habitat for MSHCP-covered bird species is limited or non-existent throughout the BCCE since it is composed predominantly of Mojave desert scrub. We continue to conduct avian surveys annually during the breeding season.
