The purpose of the above referenced project was:

Clark County purchased the Boulder City Conservation Easement (BCCE) in July, 1995 from the City of Boulder City as a partial mitigation for the incidental take of the Desert Tortoise (Gopherus Agassizi) and the disturbance of its habitat in Clark County. The conservation easement requires that Clark County provide peace officer patrol of the property on a regular basis to enforce applicable ordinances, resolutions, orders regulations and prohibited uses.

The major accomplishment or findings of this project include:

The patrol of the Boulder City Conservation Easement ("BCCE") by a uniformed police officer in a marked police vehicle has appeared to lessen the number of occurrences of illegal use of the BCCE, thereby protecting the habitat of the Desert Tortoise and other species that live in the area.
