Dear Ms. Adams:

On behalf of Governor Sisolak, as his appointed designee, this letter informs you of our transmittal submitted electronically to USEPA's State Planning Electronic Collaboration System (SPeCS) of revisions to the Clark County portion of the Nevada applicable state implementation plan (SIP). The revisions regard Clark County Air Quality Regulations (AQR) that address the emissions inventory requirements of CAA Section 182(a)(1) and the emission statements requirements of CAA Section 182(a)(3)(B) for the Las Vegas Valley nonattainment area. The Nevada Division of Environmental Protection (NDEP) requests approval of the enclosed revisions into the Nevada applicable SIP.

Clark County Air Quality Regulation Section 12.9 was revised to incorporate the emission statement requirements of CAA Section 182(a)(3)(b) into the existing emissions reporting rule. These revisions were adopted by the Clark County Board of County Commissioners on August 4, 2020.

The enclosed SIP revision provides the required base year emissions inventory for the nonattainment area and demonstrates that Clark County has an emissions statement program that meets the statutory requirements for the 2015 ozone standard. This SIP revision was adopted by the Clark County Board of County Commissioners on September 1, 2020.
