 - a. Aged Out Foster Youth Pandemic Act
 - i. Additional \$200 a month for young adults in voluntary jurisdiction until September 2022.
 - ii. Aged out foster youth under age 27 can request additional funding to assist with rent, utilities, transportation, childcare, food, and clothing; tentatively being approved up to \$1,000. May be approved for more on a case-by-case basis. Pandemic funds are available until September 2022.
 - iii. Youth in care who are aging out are eligible to remain in care until October 1, 2021.
 - iv. Increased staffing at IL and Step Up to cover the increased cases and additional case management services.
 - v. State is doing campaigns to spread the word to get young adults to contact IL for additional funding.
 - b. HopSkipDrive for transportation for foster youth to employment, meetings, etc.
 - c. Foster care extension
 - i. Step Up Services would not change.
 - ii. Allow the county to secure additional federal funding.
 - iii. Extended subsidies for guardianship or adoption up to age 21.
 - d. LifeSet Program
 - i. About 60 youth in the program
 - ii. Launched in November 2020
 - e. Workforce Connections
 - i. Partnership with UNLV and MGM for youth employment opportunities.
 - f. FAAYT Meeting discussion

4. FAAYT - Foster and Adoptive Youth Together (FAAYT Officers)

- b. Children's Advocacy Alliance (CAA) partnership.
- 5. Clark County Social Service-Step Up
 - a. Pandemic assistance requests are being approved for adults in voluntary jurisdiction and have helped prevent homelessness.

 - c. SCE Credit Union available for young adults. A flyer will be created. Online banking and webinars offered.
 - d. Young adults in care who graduate HS or equivalency can receive the education stipend.
