PUBLIC NOTICE:

Proposed Changes to Clark County Code RE: Title 13, Chapter 13.04

Please take notice that a rule is being proposed by the Clark County Board of County Commissioners.

The proposed rule will amend Title 13, Chapter 13.04 of the Clark County Code to add Subsection 106.6.1.1 Resubmittal Fees and Subsection 106.6.1.2 Revision Fees to Section 13.04.070 Scope and Administration to include additional plan review fees. The proposed rule will also include and define language as described in Section 106.6, Permit & Fee Service Scheduled, Table 106-G.

Prior to the adoption of the proposed rule, the Clark County Board of County Commissioners is required by NRS 237.080 to make a concerted effort to determine whether the proposed rule will impose a direct and significant economic burden upon a business or directly restrict the formation, operation, or expansion of a business. Due to this, trade associations, owners and officers of businesses which are likely to be affected by this proposed rule, and any other interested persons are required to be notified and provided an opportunity to submit comments, data, or arguments to the Clark County Fire Prevention Bureau regarding whether the proposed rule will:

- a) Impose a direct and significant economic burden upon a business; or
- b) Directly restrict the formation, operation, or expansion of a business.
