#### V. Informational Items

- 1. Indian Springs Library on upcoming activities and events: Jett: Saturday food distribution is active. Craft classes are available. Tuesday bread day is active. There is a home school meet up. A monthly calendar of event is available at the library.
- 2. Indian Springs Volunteer Fire Department regarding calls for service during the past month and other fire prevention issues: Chief Garry Judd: 107 calls so far this year. November 19<sup>th</sup> is the holiday bazaar. December 10<sup>th</sup> is the Christmas Parade of Lights. There are 2 volunteers in the process of joining. Chief Fitzgerald answered some questions.
- 3. Metro regarding activity during the past month and area concerns: None
- 4. Nevada Highway Patrol regarding activity and statistics during the past month and other public safety concerns: Officer Kathy Vonk: In answer to some safety measure concerns, Creech has added rumble strips and caution light at the entrance to the Creech Air Force base. 255 citations and 14 crashes so far. 1 fatality. Saturday is the most dangerous day to drive according to statistics.
- 5. Creech Air Force Base concerning current activities at the facility: None

- 6. Clark County Parks and Recreation regarding activities and events: Kelly Vaughn: Spooktacular was successful. The holiday bizzar and parade were further discussed. Santa will be at the community center after the parade.
- 7. Clark County Administrative Services regarding Public Works requests, highway mile markers, SNPLMA park improvement/expansion project, area development projects, TAB recruitment, and any other updates from Clark County: There is a speed limit sign on Raleigh. Still working on the mile markers being incorrect. The apartment complex will return to the ISTAB and ask for support of an extension. The development beyond the Beezer development will be at the December meeting. Community concerns included: 1. Mi Casita having very confusing addresses. This has caused several problems during emergency response. 2. There are several properties around town that are fire hazards and are unoccupiable.
