I. Introduction

The issues surrounding juvenile delinquency are complex and multifaceted. In particular, these issues may involve: education, family structure, mental health, social economics, and support systems. To bring about a more positive impact towards reducing juvenile delinquency, each of these areas should continue to be addressed through programs, policies, and community organizations. Based on this premise, the Department of Juvenile Justice Services (DJJS) actively seeks collaborative partnerships with various government entities, community organizations, and the general public.

By increasing the involvement of stakeholders in the juvenile justice system of care, the objective is to develop and implement solutions that address the root causes of juvenile delinquency. By addressing the source of the issue, the intended byproduct is preventing the offense from occurring in the first place. In time, these proactive measures would thereby reduce the number of youth referrals to the DJJS.

In order to successfully identify the source of the issues, information sharing is critical. To effectively create solutions, stakeholders must make evidence-based decisions. With the juvenile justice information system (FamilyTRACS), the DJJS commits to providing its stakeholders with the relevant statistics necessary to make informed policy or program decisions. The following annual statistical report is one example of the department's commitment to sharing information.

The annual statistical report begins by providing background information on DJJS. Then the report illustrates how a case works its way through the department. Next, the report provides statistics related to the State of Nevada and Clark County. Finally, the remaining sections are devoted to a collection of reports that have been generated through the FamilyTRACS database.

The reports from the database were selected as a means to provide an overview to the juvenile justice system. The objective of this overview is to provide stakeholders with access to valuable information relating to the dynamics of juvenile delinquency in Clark County. Additionally, the summary may be useful in planning for additional services and improved processes throughout the system of care for our community's juvenile population. The reports are by no means all-inclusive. The report will continue to evolve, as there is a progressive demand for more information.

II. Department Information

The DJJS is a unique and complex public service agency that performs more than the traditional Juvenile Court functions of Probation and Detention. In particular, DJJS provides intervention services, guidance and control for youth referred to the department for acts of delinquency.

To accomplish its mission, the department consists of the following divisions: Administration, Health Care Services, Detention, Probation, and the Spring Mountain Youth Camp (SMYC).


The Administration Division is responsible for managing the daily business operations of the department. Daily operations would include Human Resources, Records, Financial Services, and responding to public inquiries. Along with daily operations, this division is responsible for the Payment Center, which receives payments for court ordered fines, fees, restitution, and custodial reimbursements. Also, under Administration is the Applications Technology & Research Unit (ART), tasks to the development and support of the information technology needs of the department. The ART unit also maintains and generates data for statistical, performance, and management reporting.

The Health Care Services provides a full spectrum of assessment and treatment services to the youth involved with the DJJS and their families. These evaluations, counseling and other treatment services are offered in the institutions, in home and through office visits.

The Detention Center is a 192-bed facility located at the DJJS campus. The facility temporarily houses male and female youth with pending court hearings or correctional placements. In order to bridge the system of care, this facility provides medical and mental health services.

The Probation Division provides intake and diversionary services to youth referred to the department for acts of delinquency. For adjudicated youth, the division provides supervision and treatment services. Services are provided on the DJJS campus, within the five neighborhood community centers, or within the community itself.

The SMYC is a staff-secure 100-bed correctional facility, which houses male youth between the ages of twelve and eighteen who have been adjudicated for serious or repeat delinquent acts by the Juvenile Court Judge. SMYC is located at Angels Peak in the Mt. Charleston Recreational/Toiyabe National Forest Area.









1. Youth Male Population by Age Group (2023 Total – 164,610)

2. Youth Female Population by Age Group (2023 Total – 157,284)




3. Youth Population by Gender (2023 Total – 321,894)





4. Youth Population by Ethnicity/Race (2023 Total – 321,894)


5. CCSD Population by Ethnicity/Race- All Grade Levels (2023 Total – 292,400)


1. Gender of Referred Youth (2023 Referred Youth – 7,094)




4. Household Composition of Referred Youth by Ethnicity/Race







c) Prior Referral Statistics for Asian/Pacific Islander Youth (2023 Referred Total - 207)






d) Prior Referral Statistics for Hispanic Youth (2023 Referred Total – 1,747)




f) Percentage Comparison of Youth with Prior Referrals by Ethnicity/Race









e) Prior Adjudicated Referral Statistics for White Youth (2023 Referred Youth – 1,669)






f) Percentage Comparison of Youth with Prior Adjudicated Referrals by Ethnicity/Race



b) African American/Black Youth Charged with F/GM (2023 Referred Youth – 3,018)






c) Asian/Pacific Islander Youth Charged with a F/GM (2023 Referred Youth - 207)




e) White Youth Charged with a F/GM (2023 Referred Youth – 1,669)




f) Percentage Comparison of F/GM Referrals by Ethnicity/Race





B. Referral Types

Referrals to the Clark County DJJS are received in a variety of ways. A majority of youth comes to the attention of the DJJS through a Juvenile Referral which includes *citation*, *arrest, field booking and ICOJ*. Citation involves law enforcement recording the charges of the youth and directing them to appear for an appointment at the Intake division of the DJJS. This process is similar to receiving a *Traffic* ticket. Law Enforcement Arrest is when a youth is physically taken to the DJJS to be booked and evaluated for detainment. Field bookings is when charges are added to a youth's record without having the youth physically brought into Booking. ICOJ stands for Interstate Compact on Juveniles, which is a formal process between states where a youth is placed under supervision in one state and supervised in another. Another referral types are *Juvenile Traffic Citation* and *Summons* or a *Writ* of Attachment, which are court generated documents that require a youth to appear in court.

1. Referral Types (2023 Total Referrals - 9,412)
















e) Prior Referral Statistics for White Youth (2023 Referrals – 1,970)


f) Summary of the Number of Prior Referrals by Ethnicity and the Percentage of Overall Referrals in 2023




b) Number of Prior Adjudicated Referrals for African American/Black Youth (2023 Referrals – 4,316)








e) Number of Prior Adjudicated Referrals for White Youth (2023 Referrals – 1,970)


f) Summary of the Number of Prior Adjudicated Referrals by Ethnicity and the Percentage of Overall Referrals in 2023

5. Quashed Arrest Writ Statistics by Ethnicity/Race (2023 Arrest Writs – 72)



VI. **Diversion Statistics**

The Probation Intake Unit provides the initial interview, evaluation and assessment with youth and families, utilizing a validated youth assessment tool that identifies a youth's initial risk level. This information is used to determine the most appropriate treatment recommendation, which includes an emphasis towards diversion services for low-risk offenders, while still holding them accountable for their actions. Some of these diversion services are:

- Diversion Court Program Intervention services/programs that redirect youth away from formal processing in the juvenile justice system.
- Further Proceedings Court Ordered disposition that places the client on supervision but defers the adjudication process based on the completion of conditional sanctions.
- Hold Open Informal diversion services that address appropriate diversion conditions of clients within a finite timeframe (Generally 30-60 days).
- Informal Supervision Refers to judicial orders for Stayed Adjudication, Dispositional Hold Open Agreement, Unsupervised Probation, Deferred Adjudications or Referred back to Intake.
- Probation without Supervision (PwoS) Formal supervision cases that were downgraded to unmonitored supervision.
- Referred to The Harbor- Outsourced agency that assesses clients to provide guidance and support.

As a referral may have more than one offense, one referral may generate multiple diversion categories. Therefore, the categories will not add up to the grand total.






B. Top 10 Offenses Filed in 2023. The top 10 filed offenses accounted for 49% of total offenses filed.


C. Top 10 Filed F/GM Offenses in 2023. The top 10 filed F/GM offenses accounted for 51% of total F/GMs filed.




A. Formal Probation Dispositions by Ethnicity/Race (2023 Distinct Youth – 1,426)


B. SMYC Dispositions by Ethnicity/Race (2023 Distinct Youth –132)


C. Detention Average Length of Stay (2023 ALOS – 29 Days)


D. Detention Average Daily Population (2023 ADP - 167)

X. <u>Alternatives to Detention</u>


This section illustrates statistics that are related to alternatives to detention: Intensive Supervision Unit (ISU) and Electronic Monitoring (EM). Pre-Adjudicated and Post-Adjudicated youths are eligible. ISU and Electronic Monitoring are designed to provide intensive supervision services to youth in the community rather than in the secure detention facility. EM is a high-level supervision program which requires a youth to wear an electronic tracking device (GPS). This program restrict youth to their home and permits travel only to and from school, employment, etc. Supervision includes un-scheduled on-site visits at home, school or employment, and un-scheduled phone contacts. The youth will maintain a scheduled daily routine agreed upon by the youth, parents, and ISU staff.


XI. Spring Mountain Youth Camp Statistics



C. Average Daily Population (2023 ADP - 71)








B. Average Formal Probation Caseload per Month (2023 – 1,940)






B. Harbor Youth Served by Ethnicity/ Race

C. Harbor Youth Served by Age (2023 Youth Served – 5,817)





E. Top 5 Sources of Total Harbor Referrals (2023 Total Referrals – 10,725)







B. TPOP Youth Served by Ethnicity/ Race (2023 Youth Served – 3,572)



F. TPOP Youth Served by Age (2023 Youth Served- 3,572)


