- XII. Eric Gant, Coordinator, Clark County School District Attendance Enforcement Office
 - Eric Gant is the residence expert at Clark County School District with regards to truancy. Mr. Gant went over the notification process for truancy for the elementary and secondary schools. Families receive three notifications letters. The letters are sent to the address that is on file with the school. Phone calls and meeting with parents are also done in English & Spanish. The notification letter can go out with the first unexcused absence. If a child missed school all day the school can place a phone call. If a child is out three days Child Protective Services (CPS) can get involved. An agent from CPS will do a home visit. Kids get citations once they are twelve years old. Mr. Gant stated that this based on the CCSD Statute.
 - Mr. Grant also discussed credit deficiency youth with regards to diversion programs, etc.
 - Mr. Reese stated that the Nevada Revised Statute dictates that confidential information is not shared amongst agencies.
 - Louise Helton suggested to Mr. Gant that there needs to be a parent orientation done. She further stated that the Latin Chamber of Commerce would possibly be willing to help. This would be a great topic for the Citizens Advisory Committee's town hall meeting on **January 18, 2012 at 6 PM.**
