- V. Receive the Director's Report on the Activities of the Department of Juvenile Justice Services (DJJS
 - a. Budget/Personnel Update
 - **i.** There will be 7 staff in our next academy starting September 26, 2017. That leaves 6 vacant positions.
 - **ii.** New DJJS Assistant Managers are Dean Steiner for Detention and Alfred Kermode for Spring Mountain Youth Camp. Steiner and Kermode were both Juvenile Probation Supervisors, therefore leaving two openings at that level.
 - **b. Legislature** Our focus is still ensuring the necessary funds are available for The Harbor.
 - **c. Juvenile Detention Reform -** The Juvenile Justice Reform Commission has submitted our front end diversion requests for approximately \$2.2 million. That money is allocated for a Gender specific program and getting The Harbor open 24 hours a day.
 - d. Juvenile Justice Programming
 - **i.** Family Tracks 2.0 will be available for use in February 2017.
 - **ii.** We continue to build on our intake tool to ensure more consistent recommendations are made by Probation Officers.
 - iii. DJJS is working on opening a second Spring Mountain Residential Center.
 - **iv.** We have not found a new East side location that can meet the expectations DJJS and our partners have in mind.

e. The Harbor Update (formerly known as the Assessment Center) – Assistant manager Lemos is working with the two probation officers that will be assigned to the Harbor. Tentative SOFT opening October 17, 2016. The Harbor will be located in the Educational area of Detention until Metro's building is ready. In that time, we will streamline our processes, ensuring quality programming and wrapping youth in meaningful services.
