VI. Receive the Director's Report on the Activities of the Department of Juvenile Justice Services a. Budget/Personnel Update

- **i.** Mr. Martin is in the process of hiring a second Assistant Director position. The position will open in the near future.
- **ii.** A previously vacated DJJS Principal Accountant position was approved to fill as a Senior Management Analyst. This will expand our grant writing, data reports and analysis and allow focus on quality assurance overall. This will be a promotional opportunity; posting in the near future.
- **iii.** There are currently 16 P.O. vacancies within DJJS. A new JPO II Academy will begin early 2019.
- b. Legislature
- i. Harbor expansion remains a focus for 2019 Legislation.
- ii. Mr. Martin remains cognizant of the consistent, inflated Detention population, as it relates to the process and placement of certified youth. Mr. Martin will continue to ensure DJJS management stays abreast of any Assembly bills that could impact this matter. There are currently 17 youth housed in our detention facility, which belong to the State and are pending placement. There are currently 21 youth on parole as well.

c. Juvenile Detention Reform

- i. The new Spring Mountain Residential Center (SMRC) located at 520 North 30th Street (right by the current SMRC) is scheduled to open by February 2019. Currently there is no funding to reconstruct the previous building but that is the eventual goal for DJJS.
- **ii.** Mr. Martin is working with County Commissioners and other partners to remodel the Sunrise Community Center on Lake Mead and Christy. The building has great potential but will require a lot of work. The goal is to have a pool, large kitchen,

- mechanic shop, baseball field, etc. This will give youth the opportunity to learn life skills such as culinary classes, lifeguarding, landscape, sports, etc. We also plan to have another Harbor located here, as well as an Evening Reporting Center.
- **iii.** Probation Manager, Dean Steiner, will be traveling to Fairfax County to observe front end probation practices. DJJS is still in the process of making changes based on our RFK audits, so this is perfect timing for Mr. Steiner to get more recommendations.
- **iv.** We continue to see a decreased amount of school referrals made to DJJS, thanks to the School Justice Partnership. There are 30% less referrals than last year at this time.
- v. Our training team is conducting their first Implicit Bias Training in November. The training is called Clark County Juvenile Justice Presents 27/7. It is a 3 day training that focuses on juvenile justice reform, self-reflection and many other components that are not addressed in any other County training. Starting January 2019, all DJJS staff will be mandated to attend.

d. Juvenile Justice Programming

- i. The Mental Health Court cannot begin until the State starts the YLS implementation.
- **ii.** Mr. Martin is working with Workforce Connections on how to make programming more accessible in classrooms. We want youth to have the opportunity for vocational training and obtaining licenses or certifications, prior to leaving High school. Ideally, they will reach out to CSN subsequently, with the hope that continued education is not only accessible, but a priority.
- **e. The Harbor Update -** Both Harbor locations continue to succeed. The newest location has been open 3 weeks and has served over 100 families already! There is a new Impact Program that assists schools with behaviors inside the classroom. If you have not visited Harbor locations, please contact the specific Directors office to schedule a tour!
