- VI. Receive the Director's Report on the Activities of the Department of Juvenile Justice Services a. Budget/Personnel Update
 - i. The second Assistant Director position has posted County wide and will close 1/4/19.
 - ii. Our next JPO II Academy will begin February 25th.
 - **iii.** The vacant Senior Management Analyst position has closed online. We have interviews set for early January. There is also a Management Analyst position that will open in the next few months.
 - b. Legislature
- **i.** Harbor expansion remains a focus for 2019 Legislation. Mr. Martin has support from Assembly woman Daniele Monroe-Moreno.
- c. Juvenile Detention Reform
 - **i.** The new Spring Mountain Residential Center (SMRC) is scheduled to open by February 2019. Mr. Martin would like to use the existing building for girls programming.
 - ii. No update-Mr. Martin is working with County Commissioners and other partners to remodel the Sunrise Community Center on Lake Mead and Christy. The building has great potential but will require a lot of work. The goal is to have a pool, large kitchen, mechanic shop, baseball field, etc. This will give youth the opportunity to learn life skills such as culinary classes, lifeguarding, landscape, sports, etc. We also plan to have another Harbor located here, as well as an Evening Reporting Center.
 - **iii.** We continue to see a decreased amount of school referrals made to DJJS, thanks to the School Justice Partnership. There are 32% less referrals than last year at this time.
 - iv. No update-Our training team is conducting their first Implicit Bias Training in November. The training is called Clark County Juvenile Justice Presents 24/7. It is a

- 3 day training that focuses on juvenile justice reform, self-reflection and many other components that are not addressed in any other County training. Starting January 2019, all DJJS staff will be mandated to attend.
- v. Group homes will receive a drastic rate reduction starting January first due to recent changes in Medicaid funding. Potential options are being discussed as we currently have 60 youth placed in group homes that could lose placement when this happens. This also put a hardship on our programming and youth that rely on Medicaid.

d. Juvenile Justice Programming

i. No update-The Mental Health Court cannot begin until the State starts the YLS implementation.

e. The Harbor Update

- i. Last month we celebrated the Harbor's second year anniversary of opening. More than 5,000 families have been served with less than 400 youth reoffending! This location is at 861 N. Mojave Rd, Las Vegas, NV, telephone # 702-455-6912. This site is open 24/7.
- **ii.** Charleston Harbor has opened its doors for business! They are located at 6161 W. Charleston Blvd. building #2, Las Vegas, NV 89146. Telephone # is 702-486-5331. They are currently opened 8am-10pm 7 days a week. The Harbor has already served more than 100 families in the short time it has been open.
