- VI. **Receive the Director's Report on the Activities of the Department of Juvenile Justice Services**
 - a. **Budget/Personnel Update**
 - i. Our budget remains flat. We currently have 21 vacancies. JPO recruitment is currently open.
 - ii. The new Academy will begin September 24.
 - iii. There are 5 new supervisors that were recently promoted; Gary Reed (SMYC), Fhila Gallegos, Ruthanne Schnaible, Matthew Richardson, and Robert Myers (all assigned to detention).
 - b. **Legislature** – The goal for 2019 legislation is to get funding for 5-6 more Harbor locations. Steps have been taken to engage individual legislators to support draft language to adopt Harbors into our statute.
 - c. **Juvenile Detention Reform**
 - i. The relocation of our Eastside Probation center, located at 4475 S. Pecos Road, is moving along. Required ADA modifications, HVAC replacement, roofing improvements, etc. are being completed now. Once opened, our records department will move in as well as an additional Evening Reporting Center (ERC), a new Harbor location, a probation school, and many other exciting vocational opportunities for youth.
 - ii. The School Justice Partnership is rapidly growing. This will build and improve our relationships and communication between DJJS, CCSD and law enforcement agencies as well. The MOU was signed in front of the board on August 23! Mr. Martin is the chair for a sub-committee working on a matrix system to keep consistency on consequences for youth, to help determine what level of assistance is needed for each youth, and to add accountability to all involved.

- iii. DJJS continues to work on improvements recommended from the trauma informed audit completed by an outside agency. There are sub-committees updating policies, implementing changes, etc.
- iv. DJJS is implementing and conducting an implicit bias workshop for staff over the next fiscal year. This will entail specific curriculum focused on juvenile justice reform. The training will be required for all DJJS staff and we hope to open it up to CCSD and law enforcement agencies as well. A training team of 10 staff was chosen. Four of those employees attended a training we mirrored from Denver Police Department.
- v. Recent Medicaid changes will change our process and procedure on placing youth in group homes. There is now a requirement that youth have an independent physical and medical exam prior to being placed.

d. Juvenile Justice Programming

- i. The new ERC is ready for business! Our probation officers are looking for youth that can benefit from the services offered here. Some of those services include tutoring, pro-social activities, Thinking for a Change classes, assistance with Court orders, community service, meals on hand, etc.
 - ii. We are still waiting on the State for an implementation plan for the new state required assessment tool. Our finance department is allocating money for training in case that is not provided by the State. Once our staff is trained, we will offer department specific training to the DA’s, PD’s, Hearing Masters, etc.
 - iii. The new database is scheduled to go live before 2019. We continue to test and program special features and functions specific to DJJS.
 - iv. We are excited to announce SMYC has a soccer team! Please find game information below (though most games are scheduled weekly) and come support our boys.
- e. The Harbor Update** - The Harbor is coming up on their 2 year opening anniversary. There will be an event to celebrate its success so far. Invites to come! More than 4,700 families have received services through the Harbor and our partners. The second location, Harbor West, located at 6161 West Charleston Boulevard, is scheduled to open later this year.

- d. Post juvenile justice transitional services** – Mr. Martin continues to talk with Job Corps in hopes to get a residential center in our community. The City of Las Vegas is involved now as well as this would help our community as a whole.
