- VI. Receive the Director's Report on the Activities of the Department of Juvenile Justice Services**
 - a. Budget/Personnel Update**
 - i.** The second Assistant Director position remains vacant.
 - ii.** Our next JPO II Academy will begin February 25th and will finish April 19th. Even though there are 20 vacancies, only 8 cadets made it through the hiring process.
 - iii.** Stacey Demetrias, from downtown Clark County Finance, has filled our Management Analyst II position.
 - iv.** DJJS had 17 budget requests including increased mentoring dollars, specific to girls programming, girls continuum care, a new detention center, expanded community programs, Harbor expansion, etc.
 - b. Legislature**
 - i.** Legislation began February 4.
 - ii.** There are certification bills we are monitoring that could force unfunded mandates on the agency.
 - c. Juvenile Detention Reform**
 - i.** My Brother's Keeper Las Vegas Alliance held its third annual conference, No Student is Unreachable: School and Community Solutions for Student Success on January 17, 2019. This year we had over 500 people attend. Speakers included Principal Akbar Cook and Mr. Wes Hall as well as a performance by Toe Tag Monologues.
 - ii.** DJJS received a grant from OJJPD for technical assistance.
 - iii.** Mr. Martin continues his work with the School Justice Partnership. There is a focus on chronic absenteeism. There are effective programs in other states that we will be looking at. Keeping kids in school and addressing this issue at a younger age ultimately keeps kids out of the juvenile justice system.
 - d. Juvenile Justice Programming**
 - a.** DJJS is still on hold for the mandated YLS implementation.

- b. No update-Caseload Pro has a new owner causing a transition time before we can go live. There are still many features being added or tested such as automatic calls and texts to families who have upcoming court dates.
- e. **The Harbor Update** – More than 6,500 families have been served at our Harbor locations. The third Harbor location will be in our new Eastside center on Charleston and Pecos. Our recidivism rate is still only 5%.

VII. CAC Strategic Goals

- a. **Increase programming to improve client outcomes, using evidence based practices and measuring performance** – DJJS is ready to implement YLS mandates but must wait for the State for training.
- b. **Reduce disproportionate minority contact through the use of targeted strategies and programs** – We continue to make changes to our processes and procedures based on the Robert F Kennedy (RFK) probation review results.
- c. **Post juvenile justice transitional** – We are in hopes that a stronger relationship with Department of Family Services will come with our dual custody unit starting soon.
- d. **Improve facilities to provide increased security and increased rehabilitative and vocational opportunities**
