It was moved and carried that the library request an updated job description for the Law Library Director from Clark County Human Resources, as well as from Karen Byrd, since she is currently performing the duties.

It was moved and carried that the library confirm with Clark County Finance the salary the board may offer a replacement Law Library Director, based on its current budget.

It was moved and carried that the library fill the vacant part time Law Library Assistant I position, while the full time Law Library Assistant I position remain vacant at this time.

It was moved and carried that the revised Patron Code of Conduct be adopted.
