Message from the Director

The Clark County Law Library provides free access to legal resources to the 2 million residents who live in Clark County. One of the misconceptions about the Law Library is that it is only open to judges and lawyers. Over the past 2 years since I was appointed Director of the Law Library, I have committed to educating the public about the free legal resources available to assist with their legal issues and ensure that all residents have free access to justice. It has been my pleasure to assist the Clark County Law Library in becoming a first rate public law library with up-to-date legal resource material, free online legal databases and qualified staff to aid patrons in using the legal resources that we offer.

Additionally, I would like to take this opportunity to confirm to the Clark County Board of County Commissioners that the Clark County Law Library continues to adhere to NRS 380.153 (2), which mandates that all legal books and materials listed by the State Library and Archives Administrator are to be accessible to the inhabitants of the county during normal business hours and are in an area that is plainly marked as being accessible to the general public. I would also like to note that the Law Library also adheres to the standards established by the American Association of Law Libraries, through the State, Court and County Law Libraries Special Interest Section.

The safety of staff and patrons utilizing the Law Library has been a concern of mine for many years. In February 2015, I requested a security assessment from Theodore Hooper, Clark County Law Library Real Property Manager. Roger Barrera, Clark County Security Supervisor, prepared an extensive report and indicated safety concerns for staff and patrons utilizing the Law Library. I'm happy to report that all areas of concern in the Law Library have been properly addressed and a security plan has been prepared, which is reviewed by staff every six months.

2015 has proven to be one of our most successful years yet at the Law Library. I would like to invite you to review the year's highlights which outline: service developments, initiatives and community involvement that marked this past year. I would personally like to thank the Clark County Law Library Board of Trustees, Clark County Manager's Office, our dedicated employees, and interns that made 2015 such a successful year for the Clark County Law Library. With all of their continued involvement and support, I look forward to another successful year in 2016.

Overview

The Clark County Law Library was created in 1923 by the enactment of Ordinance #1 and is statutorily mandated by NRS 380. The Law Library provides free access to legal resources to the 2 million residents of Southern Nevada. We are open to the public and are funded by a portion of District Civil Court filing fees and a small portion of Justice Court filing fees, membership dues, sanctions and photocopy usage.

The Law Library is governed by a seven-member Board of Trustees composed of three District Court judges (appointed by Chief Judge), two attorneys and two non-attorneys (appointed by Clark County Commissioners), of which all serve without compensation. The Clark County Law Library Board of Trustees is committed to public service through the free legal information resources and programs made available to every resident in Clark County.

The Law Library is open 6 days a week, Monday - Saturday for a total of 52 hours a week with seven full time and three part time staff members. The Law Library is currently in its first year of collaborating with local high schools to offer an up to 8 hours per week internship program to students who are interested in pursuing various careers within the legal field such as that of law librarian, attorney, or paralegal.

NRS 380.020 Government and management of law library; number, appointment and terms of members.

- 1. Any law library established by ordinance as provided by subsection 1 of <u>NRS 380.010</u> must be governed and managed by a board of law library trustees.
- 2. A board of law library trustees must consist of not less than five nor more than seven members. The district judge of the judicial district in which the county is situated or, if the district has more than one district judge, a maximum of three district judges designated by all the judges of the district from among their number, are ex officio trustees. The board of county commissioners shall appoint a sufficient number of trustees to complete the board, including at least two who are not attorneys at law.
- 3. Appointive members of the board must be appointed by the board of county commissioners at the first meeting of the board of county commissioners in each January, to serve for terms of 2 years. As nearly as may be, half of the terms must expire each year.






Budget/Finances

The main source of funding for the Clark County Law Library comes from a portion of selected District Court civil filings as stated in the Clark County Code 18.08.030(1) in the amount of \$30 per civil action. Additionally, we receive a small portion of selected Justice Court civil filings as stated in Clark County Code 18.08.030(2) in the amount of \$3 per selected civil action. Approximately 89% of the total Law Library's revenue is derived from District Court civil filing fees, which totaled \$956,465.07 in FY2015.

Funding for law libraries throughout the country continues to be a major concern. Since the number of Justice Court litigants seeking legal assistance at the Law Library has continued to rise, the Clark County Law Library Board of Trustees felt it was the appropriate time to request additional funding from the Justice Courts. Maggie Lambrose, Secretary of the Clark County Law Library Board of Trustees, and Nevada Legislators advocated for Justice Court filing fees, and the additional revenue became a reality on January 1, 2014, in the amount of \$3 per selected civil action. In FY 2015, the Law Library received \$82,361 in Justice Court filing fees.

Even as the Law Library has faced financial challenges since the 1980's, the staff continues to provide and maintain a high level of professional service and strives to enhance services to assist the public, legal community, judiciary, and all branches of government.




Gate Statistics


Gate Count



Gate count reflects the number of individuals utilizing services within the law library.







Circulation Activity




Circulation is limited to active members of the Nevada State Bar, Judicial Staff, and County Departments that have a valid circulation card and are in good standing with the Law Library.

To obtain a circulation card, an individual must fill out a Borrower Registration Card, either in person at the Law Library or on the Law Library's website at www.ClarkCountyNV.Gov/LawLibrary. Along with the registration card, there is a one-time \$50.00 registration fee. The circulation card is then valid for one year from the date of purchase and can be renewed annually for \$30.00 per subsequent year.

Library Collection

The Clark County Law Library has a total of 87,146 materials along with 501 online resources in its collection. In addition to the books, the Law Library offers free usage of legal databases which include Lexis/Nexis, Westlaw, M-Law, CCH IntelliConnect, BNA electronic legal resources, and Hein-on-line, which otherwise would not be available to the general public without the purchase of an annual subscription with each vendor.



Community Involvement

For the first time in over 35 years, the Clark County Law Library offers a variety of community awareness opportunities to inform members of the general public and the legal community of the free services the Law Library has to offer.

- **CLE Credit Opportunity:** The Clark County Law Library offers a variety of free monthly CLE credit opportunities for attorneys and paralegals to meet their annual continuing legal education requirement. In 2015, 295 attorneys and paralegals participated in the monthly event.
- Criminal Record Sealing Class and Civil Rights Restoration in Nevada: In July of 2015, the Clark County Law Library in collaboration with Nevada Legal Services, William S. Boyd School of Law, Legal Aid Center of Southern Nevada and American Civil Liberties Union of Nevada began offering a free workshop designed to provide information regarding the process of Record Sealing and Civil Rights Restoration. This workshop is offered every Wednesday from 3-5pm at the Clark County Law Library. With the overwhelming response, reservations are now required. From July 29, 2015 to date, 231 Clark County residents have participated in this workshop.
- Estate Planning Seminar: In December 2015, the Clark County Law Library in collaboration with Nevada Legal Services began the first free workshop on Estate Planning. This workshop is designed to assist the general public on how to avoid probate, understand a trust, make health care and financial decisions and learn how to receive free assistance. The first workshop was held on December 15, 2015, in which 12 Clark County residents participated. This event will continue through 2016.
- Bankruptcy and Consumer Rights Seminar: In December 2015, the Clark County Law Library in collaboration with Nevada Legal Services began the first free workshop on Bankruptcy and Consumer Rights. This workshop was designed to assist and educate the general public on filing for bankruptcy protection, differentiating between Chapter 7 and Chapter 13, debt collector harassment and learning how to receive free assistance. The first workshop was held December 16, 2015, in which 8 Clark County residents participated. This event will continue through 2016.
- Access to Justice: Staff participates in quarterly meetings with the Nevada Supreme Court
 Access to Justice Commission.
- S.A.L.T. (Senior and Law Enforcement Together Council): Two staff members are a part of the S.A.L.T. committee which meets monthly to promote senior safety throughout Clark County.

- Ask the Expert Day: The Law Library is represented in this annual event hosted by Clark County
 to inform the public on services offered at the library to assist self-represented litigants with
 their legal needs.
- Law Day: Open house to introduce the legal community and self-represented litigants to free legal resources available in the Law Library. All patrons who visited the Law Library on Law Day received a free copy of the United State Constitution.
- Site visits include the following locations: Staff visits 90 locations throughout the year which include all District and Justice Courts throughout Clark County, Legal Aid Agencies, Regional Justice Center, Self Help Centers, Federal Courts, Community Centers, Public Libraries, Detention Centers, High Schools specializing in the law, LVMPD, Constables and other miscellaneous agencies that assist the legal community in Clark County.
- **High Desert State Prison:** Clark County Law Library staff along with Clark County Law Library Board of Trustees members Maggie Lambrose, Secretary, and Hon. Jerry A. Wiese II, met with the Warden of the prison to tour their law library and find out how to provide prisoners with the services needed to perform legal research and ensure proper formatting of pleadings in order to expedite the filing process. This is an ongoing project working with Law Library staff, Boyd Law School, District Court and High Desert Prison.
