Message from the Director

The Clark County Law Library provides free access to legal resources to the 2 million residents who live in Clark County. The staff at the library is committed to educate the public about the free legal resources available to assist with their legal issues and ensure that all residents have free access to justice. The Clark County Law Library continues to be a first rate public law library with up-to-date legal resource material, free online legal databases and qualified staff to aid patrons in using the legal resources.

In 2016, over 35,000 people visited the Clark County Law Library and over 80,000 people visited our website in need of legal research assistance. The library along with Nevada Legal Services, American Civil Liberties Union, VegasPBS and Boyd Law School continues to provide bi-weekly, monthly and annual free legal educational seminars to residents in Clark County by hosting the following events: Bankruptcy, Criminal Record Sealing, Criminal Record Sealing Forms Clinic, Estate Planning, Know your Civil Rights, Probate under \$100,000, Tenant's Rights Clinic, Veterans Ask-A-Lawyer Clinic and Wills Carnival. The library also hosts monthly free CLE seminars for the legal community in Clark County. This year the library assisted over 1,400 members of the public, attorneys and judges throughout Clark County in this manner.

I would like to thank the Clark County Law Library Board of Trustees, Clark County Manager's Office, our dedicated employees, and interns that made 2016 another successful year for the Clark County Law Library. With all of their continued involvement and support, I look forward to another successful year in 2017.

Overview

The Clark County Law Library was created in 1923 by the enactment of Ordinance #1 and is statutorily mandated by NRS 380. The Law Library provides free access to legal resources to the 2 million residents of Southern Nevada. We are open to the public and are funded by a portion of District Civil Court filing fees and a small portion of Justice Court filing fees, membership dues, sanctions and photocopy usage.

The Law Library is governed by a seven-member Board of Trustees composed of three District Court judges (appointed by Chief Judge), two attorneys and two non-attorneys (appointed by Clark County Commissioners), of which all serve without compensation. The Clark County Law Library Board of Trustees is committed to public service through the free legal information resources and programs made available to every resident in Clark County.

The Law Library is open 6 days a week, Monday - Saturday for a total of 54 hours a week with seven full time and two part time staff members. The Law Library continues to collaborate with Veterans Tribute Career & Technical Academy and offer an internship program to students who are interested in pursuing various careers within the legal field such as that of law librarian, attorney, or paralegal. The Law Library has also collaborated with AARP "Back to Work 50+" program which is specifically designed for seniors in need of new networking techniques and training opportunities. The program offers practical strategies for finding meaningful work and overcoming the hurdles of long-term unemployment.

NRS 380.020 Government and management of law library; number, appointment and terms of members.

- 1. Any law library established by ordinance as provided by subsection 1 of <u>NRS 380.010</u> must be governed and managed by a board of law library trustees.
- 2. A board of law library trustees must consist of not less than five nor more than seven members. The district judge of the judicial district in which the county is situated or, if the district has more than one district judge, a maximum of three district judges designated by all the judges of the district from among their number, are ex officio trustees. The board of county commissioners shall appoint a sufficient number of trustees to complete the board, including at least two who are not attorneys at law.
- 3. Appointive members of the board must be appointed by the board of county commissioners at the first meeting of the board of county commissioners in each January, to serve for terms of 2 years. As nearly as may be, half of the terms must expire each year.





Budget/Finances

The main source of funding for the Clark County Law Library comes from a portion of selected District Court civil filings as stated in the Clark County Code 18.08.030(1) in the amount of \$30 per civil action. Additionally, we receive a small portion of selected Justice Court civil filings as stated in Clark County Code 18.08.030(2) in the amount of \$3 per selected civil action. Approximately 91% of the total Law Library's revenue is derived from District Court civil filing fees, which totaled \$973,609.77, and Justice Court civil filing fees totaled \$87,485 in FY2016.

Even as the Law Library has faced financial challenges since the 1980's, the staff continues to provide and maintain a high level of professional service and strives to enhance services to assist the public, legal community, judiciary, and all branches of government.



Fund 2140 Law Library


Gate Statistics


Gate Count








Circulation Activity




Circulation is limited to active members of the Nevada State Bar, Judicial Staff, and County Departments that have a valid circulation card and are in good standing with the Law Library.

To obtain a circulation card, an individual must fill out a Borrower Registration Card, either in person at the Law Library or on the Law Library's website at www.ClarkCountyNV.Gov/LawLibrary. Along with the registration card, there is a one-time \$50.00 registration fee. The circulation card is then valid for one year from the date of purchase and can be renewed annually for \$30.00 per subsequent year.

Library Collection

The Clark County Law Library has a total of 84,944 materials along with 399 online resources in its collection. In addition to the books, the Law Library offers free usage of legal databases which include Lexis/Nexis, Westlaw, M-Law, CCH IntelliConnect, BNA electronic legal resources, and Hein-on-line, which otherwise would not be available to the general public without the purchase of an annual subscription with each vendor.



Community Involvement

In 2016, the Clark County Law Library continued to expand our community outreach opportunities.


