## DOCUMENT SUBMITTAL REQUIREMENTS

A submittal package must include a request for the non-standard improvements with an outline of the improvements and verification if additional easements may be needed. **NOTE: ALL required documents and exhibits must be letter or legal size with a minimum 10pt font for legibility/recordation** 

□ Fee of \$75.00

Fee of \$50 for an extension of time

Additional \$50 fee for incomplete packages

- □ Copy of the request requiring license and maintenance agreement application and Notice of Final Action from Comprehensive Planning.
- Letter of request explaining purpose of submittal
- □ Legal description of owners property 8 ½ " X 11"
- $\Box$  Exhibit drawing depicting the owners property 8  $\frac{1}{2}$  " X 11"
- □ Legal description with exhibit for sewer line within the right of way 8 ½ " X 11" include linear feet of sewer in the right of way. (This is the figure that will be used to calculate the fee)
- $\Box$  Copy of recorded deed that vests title in the most recent property owner
- Annual Fee will be assessed at \$1,500 or \$1.50 for each linear foot. The initial amount will be collected prior to recordation, as the cash deposit, as described in the Agreement.
- Certificate of Liability Insurance for a minimum of 2 million, per each occurrence, naming Clark County as Certificate Holder, Clark County Public Works, Maintenance Division, 5825 East Flamingo Rd, Las Vegas, NV 89122.
- □ Corporate declaration of authority (or equivalent), power of attorney, or signature documentation is required if the applicant and/or property owner is a corporation, partnership, trust, or provides signature in a representative capacity

<u>Highlight</u> on the articles of incorporation, operating agreement, and/or applicable supporting documents person/persons who have the authority to sign, their title, and identify where the authority is given to convey property
