Dave Martin, Volunteer Fire Chief reported 17 Service Calls. The Captains position has been filled by Jason Douglas with an April 18th start date. Still looking to fill 1 Firefighter position and 2 Seasonal Firefighter positions. Wild Land Fire Awareness month is May. Pine Needle Pickup Day is June 4th with a Open House and BBQ to follow at the Fire Station.

Jason Bailey reported the wells have risen approximately 4 ft since February, 2022. Hand watering restrictions are still in place, The Echo reservoir on Seven Dwarfs was drained, checked for leaks and cleaned. The Hydrology Report is anticipated to be completed by May, 2022.

There are several permitees under consideration to provide tours and shuttle service to the Mt Charleston and Lee Canyon recreation areas.
