- 4. Approval of Minutes for February 14, 2023 (for possible action).
- 5. Budget Presentations (not an action item).
  - a. Stadium District in District A Proposal is to paint a mural on the wall of the overpass that faces the tailgate area of the stadium. Proposed budget: \$70,000.
  - b. Nellis Meadows in District B Proposal is to create public art and around the Nellis Meadows Recreation Center. Proposed budget: \$60,000.
  - c. Historic Marker(s) in Lee Canyon in District C Proposal is to secure a historian and general contractor to install one or more historic markers in Lee Canyon. Proposed budget: \$50,000.
  - d. Walnut Recreation Center Gym in District D Proposal is to paint a mural on the existing tile in the gym. Proposed budget: \$60,000.
  - e. Hollywood Recreation Center Fitness Room in District E Proposal is to paint a mural at Hollywood Recreation Center in the fitness center. Proposed budget: \$60,000.
  - f. Aquatic Springs Entrance in District F Proposal is to create a mural within the Aquatic Springs Facility. Proposed budget: \$60,000.

- g. Silver Bowl Art in the park in District G Proposal is to create artwork within the park. Proposed budget: \$500,000.

- 7. Identify emerging issues by the Committee at future meetings.
