- 4. Approval of Minutes for March 14, 2023 (for possible action).
- 5. Assign Jury Members to existing calls One board member will be assigned to represent the Art Committee on the jury for the following public art project; (*for possible action*)
  - a. Zap at the Stadium.
- 6. Budget Presentations- to allocate \$548,000 to new budgets (for possible action).
  - a. Stadium District Mural in District A Proposal is to paint a mural on the utility boxes under the overpass and the walls of the overpass that faces the I-15 and the tailgate area of the stadium. Proposed budget: \$112,040.
  - b. Nellis Meadows Conex Mural in District B Proposal is to create a mural on the exterior of the Conex box located within the park. Proposed budget: \$5,625
  - c. Lee Canyon Meadow Sculpture in District C Proposal is to create a sculpture within the Meadows with a historical theme. Proposed budget: \$50,000.
  - d. Walnut Recreation Center Gym Mural in District D Proposal is to paint a mural on the existing tile in the gym. Proposed budget: \$21,157.

- e. Hollywood Recreation Center Blvd Mural District E Proposal is to paint a mural on the recreation center building facing the Blvd. Proposed budget: \$46,480
- f. Aquatic Springs Lobby Mural in District F Proposal is to create a mural using sound board technology within the lobby of Aquatic Springs Facility over 30% of the wall space. Proposed budget: \$50,000.
- g. Silver Bowl Art in the park in District G Proposal is to create artwork within the park. Proposed budget: \$262,698.
- 7. Report by staff regarding monthly summary of activities (not an action item).
- 8. Identify emerging issues by the Committee at future meetings. Comments made during this portion of the agenda by individual members shall refer solely to proposals for future agenda items and any discussion shall be limited to whether such proposed items shall be placed on a future agenda. No discussion regarding the substance of any such proposed topic shall occur and no action shall be taken (*not an action item*).
