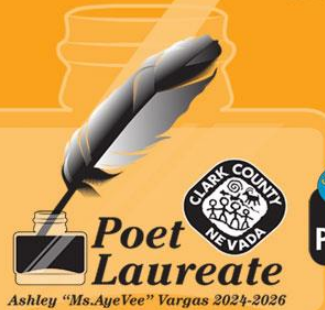

Public art promotes positive economic investment into local communities and can be a driver to help promote cultural tourism.



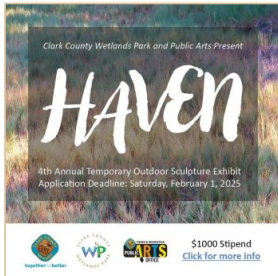
