



RED ROCK LEGACY TRAIL CYCLIST MONUMENT DISTRICT F

Scope: To create a public art piece that honors lost cyclists to be placed at the Legacy Trail parking lot/trailhead.

Funding Estimate: \$200,000

Background: The Legacy Trail was originally conceived after a prominent cyclist (Don Albietz) was killed by an 18-wheeler while riding along SR159, and as you know, there have unfortunately been too many cycling deaths over the years. There is a temporary placement of a Ghost Bike at Charleston along the Beltway Trail in memory of the five riders who were killed a few years ago near Boulder City. While that Ghost Bike could be moved to the trailhead parking lot, I think it would be a lot more meaningful if Clark County commissioned a public art piece

to honor lost cyclists to be placed at the Legacy Trail parking lot/trailhead.
