Background

The Percent for the Arts Program and associated Art Fund were established July 17, 2012. The Clark County Board of County Commissioners approved the initial County Arts Plan on December 4, 2012 and authorized the apportionment of monies from the Room Tax Collection Commission and Special Ad Valorem Capital Projects Tax to begin January 1, 2013. The Department of Parks and Recreation hired a Cultural Program Specialist to execute new art projects, initiate repair and restoration of existing public art, develop public art education opportunities and facilitate the creation of the seven-member Public Art Committee.



The first fund transfer to the County Art Fund occurred in FY 14. Following the hiring of the Cultural Program Specialist and the appointment of the Public Art Committee in August 2013, the County Arts Program was implemented. Since that time, the Public Art Committee has held regular public meetings and has evaluated existing County development projects, reviewed potential sites for commissioned art and saw the completion of the Child Haven Hope Corridor murals. The Child Haven murals brightened the walls with more than two thousand square feet of art and create a more welcoming atmosphere for children in the intake process. Five other projects are in process; *Centered*, in which ten (10) artists are creating artwork for County street medians; Siegfried and Roy Park Art by Wayne Littlejohn, now being fabricated for installation in Fall 2016; the Pebble Pedestrian Bridge Art Enhancement, to be complete 2018; the Welcome To Las Vegas Sign Experience design competition; and the Maryland Parkway Urban Design Plan.

Public Art Program staff began a condition survey of Clark County's existing public art inventory, developed recommendations for other artistic programs and projects, and held artist workshops and directed the Summer Business Institute (SBI) Art Team—a work/educational outreach program in which local high school students receive hands-on training and skills provided by professional artists and also complete public art projects. Another accomplishment of the program is the Children's Festival mosaic, created by children for Winchester Cultural Center with the help and instruction of an educator/artist. The program completed a number of

larger projects, including ZAP 6—forty-three (43) utility boxes painted by ten (10) artists in the Whitney & Parkdale neighborhood; and ZAP 7—ninety-six (96) utility boxes painted by twenty (20) artists along Maryland Parkway from Desert Inn to Russell Road; ZAP 8 in Laughlin—sixty-four (64) utility boxes painted by sixteen (16) artists.

While community involvement is sought through our current Juried Panel and artist selection process, it has been identified that the need for additional community input and notification, and enhanced communication with Commissioners whose districts are affected by upcoming projects is beneficial to our public art process. Commissioners with approved art projects in their districts will be briefed, and input sought, regarding location, style and plans for moving forward. In addition, Commissioners will receive notice, and input sought, regarding outcomes of conceptual art plans. Additional community input will be gathered through TAB agenda items related to upcoming art projects impacting the area. Announcements of upcoming art exhibits or installations will be communicated through our various media outlets, Channel 4, and sign placements.

The County Art Fund was audited in February 2016. The results of the audit were reported to the County Audit Committee and recommendations have been implemented by staff.
