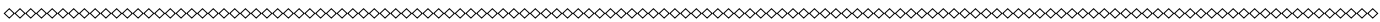

# INTRODUCTION

---

The Public Arts Office (Public Arts) is a section of the Department of Parks and Recreation (P&R) which advances the County's cultural priorities through funding provided by the County Arts Plan (Arts Plan) through programs, partnerships, and communications. Public Arts is the point of contact for many of the County's cultural initiatives and implements strategies that support the program's mission statement.

County currently does not have a cultural planning document however the cultural staff from P&R would greatly recommend this investment to coordinate our efforts according to the need of the communities we are providing cultural activities to.

This annual report sets out the prior 2024 fiscal year's related activities and funding information, in addition to proposed new projects and direction of budget for 2025 fiscal year. Budgets referenced in the summaries are for the entire term of the project and often encompass more than one fiscal year. Additionally, some projects may not have incurred expenses during this period due to budgetary policies, as they may still be in the developmental phase. These projects are considered active as staff and the evaluation committee work on developing the artist call.

The Arts Plan is just one way that Clark County invests in the cultural development of its communities.

## Mission Statement

---

The mission of the Clark County Public Arts Office and Public Art Advisory Committee is to advance arts, culture, and creativity through commissioned public arts, fostering a vibrant cultural identity in our community and beyond.



# COUNTY ARTS PLAN OVERVIEW

---

The Percent for the Arts Program and associated Art Fund were established on July 17, 2012. The Clark County Board of County Commissioners (BCC) approved the initial Arts Plan on December 4, 2012. It authorized the apportionment of monies from the Room Tax Collection Commission and Special Ad Valorem Capital Projects Tax to begin on January 1, 2013. By August 2013, Clark County had hired its first full-time employee. Funding for the Poet Laureate program was added to the Arts Plan at the October 17, 2017, BCC meeting. Funding for an additional full-time staff member was allocated in December 2019, and July 2023. The ordinance changes in fiscal year 2023 included the removal of the annual audit and increasing the cap to 2.25 million per year.

Public Arts makes rolling out permanent public art our priority. Each program offered is geared to helping our local artists qualify for these large-scale permanent public art pieces. In addition to commissioning and conserving of permanent artworks throughout the 8061 square miles of unincorporated Clark County, Public Arts facilitates the placement of temporary art, operates three of four funded galleries, youth education, adult education, portfolio reviews, advises on special committees and assigned various special projects outside the arts plan funding. These programs engage community members using parks and recreation facilities both in urban and rural areas and the Clark County Government Center. In addition, to help utilize the Arts Plan Funding, Public Arts partners with Wetlands Park to offer funding for a portion of their gallery and artist residency program, and an annual temporary sculpture project in the park. Winchester Dondero Cultural Center hosts the Poet Laureate Program and graciously shares their space for Public Arts gallery and storage space. The County Museum has partnered with Public Arts on exhibit space at the Rotunda Gallery and give expert guidance on historical public art projects. In addition, \$50,000 per year is given to the Northern Nevada Museum of Art to help fund cleanup efforts at of Seven Magic Mountains on the I-15 for five years ending July of 2027.

In 2023-2024, the Arts Plan soared to new heights in its mission to commission public arts. With the addition of a graphics/social media coordinator and a poet laureate coordinator, the program expanded its part-time staff and continued to demonstrate its dedication and hard work. We saw the completion of the design competition for the 1 October Memorial and the timely completion of 16 Zap murals around the Stadium for the Super Bowl. These are just two of the 35 permanent projects completed this year that serve as shining examples of the program's continued growth and success. As a result, there is now a request for full-time positions and a procurement software program to further enhance project management and data entry issues. The Public Art Committee has also taken steps to revise the program's mission statement and the bylaws for the advisory board, listed on the art committee webpage, ensuring its continued success in the future.

As artworks are acquired and accessioned into the arts plan collection, they, together, boost Clark County's image as a vibrant and culturally rich community.

The projects include painting, murals, photographs, playground objects, films, statues and sculptures of permanent character located on Clark County properties.

The Collection grew by 35 permanent works of art in fiscal year 2024, which includes 16 commissioned by the arts plan, 17 funded by P&R donations. In addition, 19 local artists were hired to display temporary artwork.

# FISCAL YEAR 2024

## Activity Report

In fiscal year 2024, 7 new projects were added to the arts plan for commissioning permanent artworks. 18 projects were active with 11 projects are proposed to close out by June 2024, leaving 7 projects yet to be assigned to staff, for a total of 26 project in total.

In addition to permanent projects, we offered 17 professional artists educational classes, over 300 children were engaged in creating public art, held 10 art committee meetings, and 276 artist exhibited in our galleries. We provide the community two newsletters per month. One focuses on events with over 1500 subscriptions and the other focuses on art calls with 1400 subscriptions. In addition, we have partnered to Nevada Arts Council to drive artists to their website where they can find all artists calls in one convenient location. Visit [nartscouncil.org](http://nartscouncil.org) opportunities.

The summary of activity is as follows:

**SALARIES AND BENEFITS:** One (1) Program Administrator reclassification (C29) position not filled, one (1) Cultural Program Supervisor (C28), one (1) Recreational Specialist (C26) and (9) part-time Program Assistants.

**OPERATING EXPENSES:** Art supplies, paint and painting supplies, graffiti coating, lights, office supplies and minor equipment.

**CONSERVATION:** Survey of the existing public art collection, repairs and restoration. Maintenance and restoration of existing public art.

At the beginning of FY24 Public Art maintenance had a total of 448 artworks, with 6 being decommissioned. 3 Zap, 2 sculptural and 7 mural project were added to maintenance bringing the total to 483 by 4/9/24 of the Fy24 fiscal year. Fy24 saw 8 active projects for conservation of artworks within 7 districts. 1 project is complete with 3 projected to be completed by June 2024. The 4 remaining projects expected to carry over into Fiscal Year 2025.

Of the 469 artworks within Las Vegas 297 were maintained by Gorilla property services on a monthly basis while all other public artworks in the county were maintained by public art conservator on a monthly to bi-monthly basis.

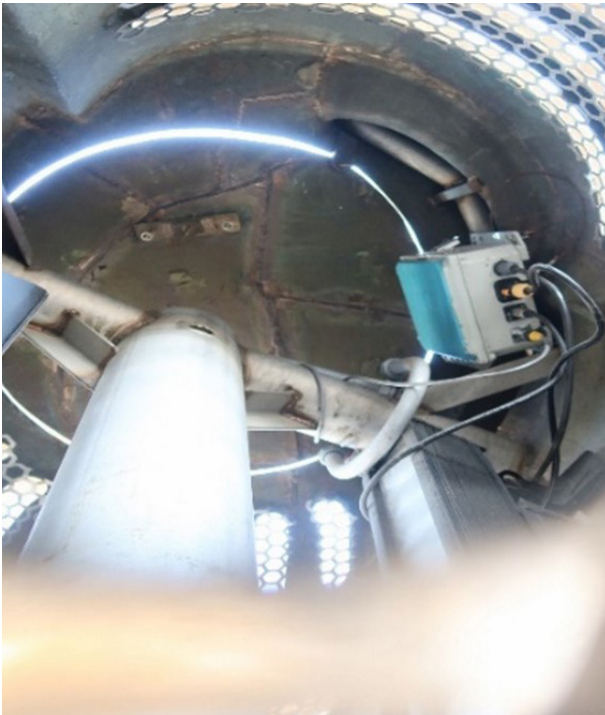

However, there was no way for the artist to connect to electrical as the project was released without proper investigation of the areas resources. Jumping to 2024 Public Works informed Public Art that when they had resurfaced the road they added a breaker to the existing lights but did not switch on the lights. Staff have spent the last four months trying to find where this breaker is and have not received any plans from Public Works.

## Youth Public Arts Education

The program's dual purpose lies in educating both artists and youth about public art, while concurrently enriching the skill sets of the participating artists. Over 300 children have participated in this program so far. Artwork is exhibited in the community centers including North and South County. At the end of the program a one-month exhibit takes place at Winchester Gallery on display from April 30, 2024 to May 30, 2024.

***Since 2018, the Youth Arts Education: Temporary Public Art Program has been pairing artists with Clark County Parks and Recreation facilities to create temporary sculptures with youth participation.***

The Public Arts Office provides gallery programming for artists in Unincorporated Clark County and beyond. We offer opportunities for artists of all skill levels, from entry-level to professional, to submit their artwork for display. Our galleries are situated in various neighborhoods including Winchester-Eastside (Winchester Gallery), Downtown (Rotunda Gallery), Historic Westside (Pearson Gallery), and the Eastside (Wetlands Gallery), each showcasing a mix of traditional, historic, and contemporary themes.

Furthermore, each exhibition is a cause for celebration. The Public Arts staff organizes receptions with the respective juror of the theme or solo artist. These events provide a platform for artists and the community to come together, network, and build friendships while enjoying light music and refreshments in a relaxed atmosphere.

Rotunda Gallery will have hosted five exhibitions programmed exhibitions this year. Starting with a non-juried special exhibition honoring the victims of the October 1 shooting in Las Vegas and ending with Living in the Dessert. So far, we have had a total of 119 artists and 316 artworks submitted to our open calls with two more planned exhibitions waiting for applicants.

The goal for Rotunda Gallery is for a more traditional elevated gallery experience. We also want to increase the visibility of our galleries program by selecting jurors that have more of a presence in the capital 'A' art world and in the artistic industries that hold up Las Vegas culture. This will ensure more of a connection between places such as the Strip and the ground-working artists that enter our exhibitions. Rotunda Gallery being our largest and most visited gallery, we hope that the exhibitions hosted there further legitimize our program and, more generally, the arts and culture of Clark County overall.

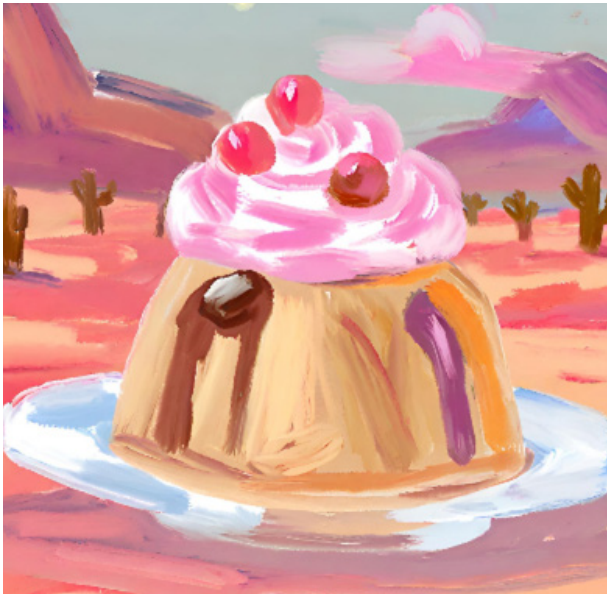

This fiscal year Winchester Gallery will have hosted seven programmed exhibitions. **5. POET LAUREATE:** To promote poetry as an art form and as a means to engage the community, with all literary programming offered to participants for free. Poet Laureate is to put on several workshops throughout the year, as well as make appearances at commissioner events.

The Clark County Poet Laureate program's mission is to promote poetry as an art form and as a means of engaging the community. Every two years, a poet is selected by an independent panel, of community volunteers, to represent the County and carry on the program's mission. The program is based at Winchester Dondero Cultural Center and runs year-round, reaching out and partnering with diverse locations throughout the County including universities, colleges, schools, libraries, local businesses, community nonprofits and community centers. The program impacts a wide range of age groups from elementary school children to senior citizens. Depending on the event led by the selected poet, the number of participants can range from small group workshops, in more intimate venues, to larger regional events, like the United States Poet Laureate presentation, which attracts hundreds of people. 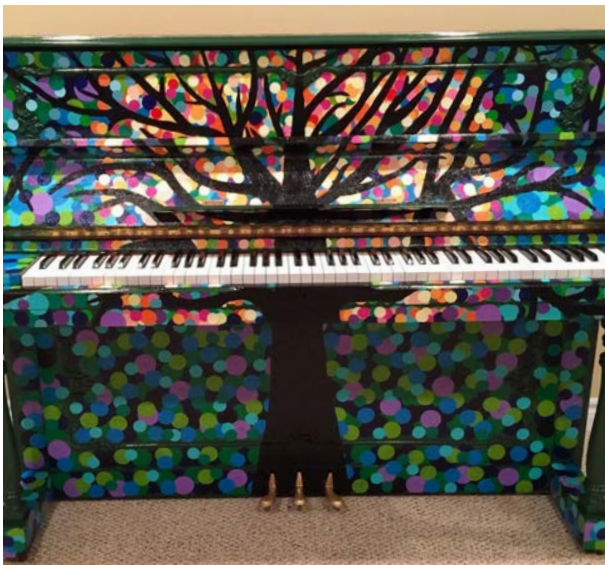

## PREVIOUSLY FUNDED PROJECTS:

### Project Funding

It is essential to recognize that funding for public art projects should encompass all expenses associated with each project to ensure its successful completion. This includes the artist's fees, consultation fees, unforeseen construction expenditures, and funding for dedications, including promotion and catering. By taking into account all expenses associated with the project, we can secure adequate funding and create something truly remarkable that will inspire and uplift our community.

### Active Projects

While some projects have not incurred expenses the majority are active as staff seek advice, plans, feasibility, approvals, etc. from a multitude of sources. The list of steps prior to putting out the call to artist is extensive. These projects are considered active as they have staff assigned and actively working on them.

### Public Art Evaluation Committees

Every project and program start with staff identifying stakeholders that can help create the call for artists. The evaluation committee, which usually includes representatives from the District Office, Neighborhood or Facility, and Public Art Committee, is responsible for much more than merely evaluating the proposed artwork. The committee creates a narrative for the artists about the community and/or facility, establishes base line for scope of work including making choices on materials and location of artwork, and establishes clear and achievable project goals.

After the staff has issued the call for artists and thoroughly reviewed the applications for completeness, the evaluation committee assesses the applications in two phases. The process of securing an artist is highly equitable, extensive, and thorough to ensure that the best candidate is selected. The evaluation committee plays a vital role throughout the project, and the staff relies on them to help find agreement and make any necessary design changes.

It is important to capture all the activities that the arts plan staff are involved in.

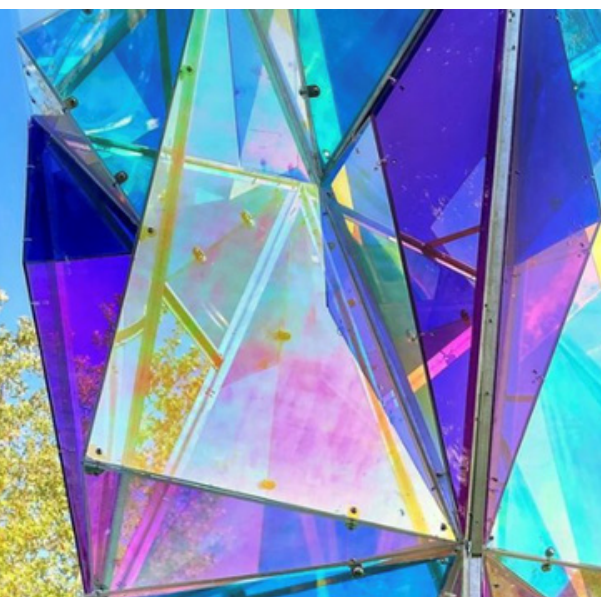

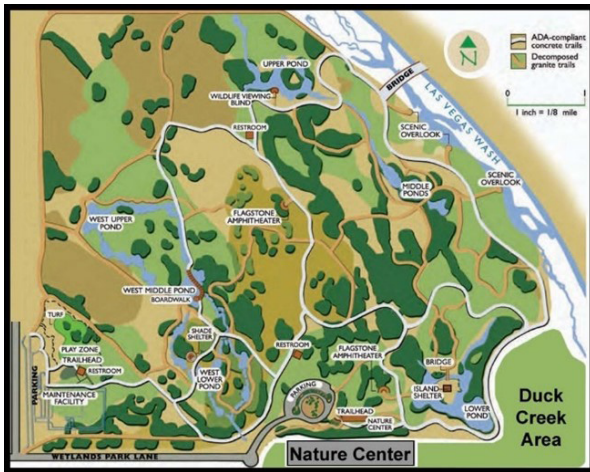

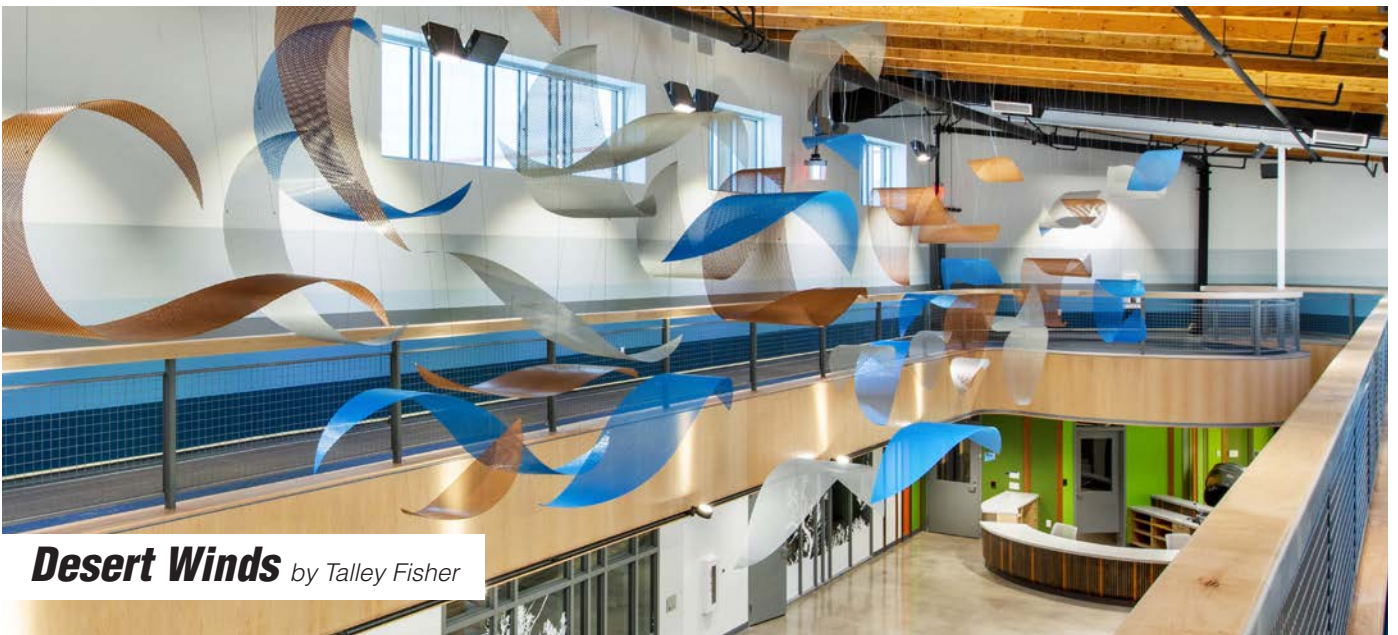

# FISCAL YEAR 2025

## Budget Recommendations

### 1. Salaries and Benefits:

Project: Program staff  
Budget: \$484,660  
Scope: One (1) Cultural Program Supervisor (C28), one (1) Recreational Specialist (C26) and (7) part-time Program Assistants.

In fiscal year 2025 Parks and Recreation is asking for additional full time staff members. Full time staff members are critical to focus on project managing the new projects and conservation the current collection. The hope is, if we add full time staff members dedicated to project management that the staff will close out these long term proposed sculpture projects and release maximum amount of funding each year for projects. Currently only one full time staff member is assigned sculptures and they are required to over see the entire program, including staffing and the art committee.

### 2. Operating Expenses:

Project: Program operating supplies  
Budget: \$140,000  
Scope: Art supplies, paint and painting supplies, graffiti coating, lights, office supplies and minor equipment.

### 3. Conservation:

Project: Survey of the existing public art collection, repairs and restoration.  
Budget: \$200,000  
Scope: Assessment, maintenance and restoration of existing public art. There are 483 projects in the collection at the start of the fiscal year.

Our collection the majority of our collection is located on streets, in parks, and trails. Our movable artwork is huge, stored or displayed throughout Clark County. While the collection is attempted to be reviewed on a monthly basis this is not always a possibility as staff travel both in and out of town and require partners to gain access to facilities, cabinets, and lock boxes.

Our outdoor collection is especially complex as the environment is unpredictable. Our murals and sculptures live in an active world with intense level of usage. Weather, earthquakes, UV light, and pollution all take its toll on the artwork. In addition, artwork is unsupervised and subject to vandalism or accidents. While projects take a long time to complete, our part-time conservation staff member has to be ready to act when a business owner contacts about graffiti, or a sculpture appears to be a danger.

Our sculptures should have a full annual inspection and address all restoration, repairs and maintenance needs. While we have hired a vendor to help remove graffiti from our Zap utility boxes, there are still 186 works of art that is to be reviewed by our part-time staff member. A conservation professional uses best practices to in documentation, including writing and photography, design drawings, and video. Constant record keeping of materials facts and care directions, as well as of conversations and artist interviews, is critical. It is important for Clark County to fund a conservation expert to oversee its investment is being maintained properly.

In fiscal year 2025 we already foresee five projects utilizing the conservation funding.

Seven Magic Mountains - District A (\$50,000 for 1 year) Allocate funding to Nevada Museum of Art for maintenance of artwork for five consecutive years at \$50,000 each year starting in FY23 (3rd yr.). Budget approved FY23 on July 19, 2023 Agenda Item #40.

Norte y Sur – District A City of Henderson is to build a pedestrian bridge on Eastern. As the artwork will be in the area it will be moved to an off site location. This makes for a great time to perform a full review of the artwork and address any needs.



Reach – District D While phase 1 is completed under projects for this year the sculpture itself is in need of repair. Staff have attempted to meet with artists to discuss next steps and beginning formulating a plan to restore the iconic piece.

Octosteam – District E To repair peeling and fading paint on sculpture.

Organic study no. 2 – District F To repair peeling of pedestal and address corrosion of steel sculpture.

#### 4. Public Art Education:

#### 5. Poetry:

Project: To promote poetry as an art form and as a means to engage the community.

This year the poetry program is going to change. The Poet Laureate will be identified later in the fiscal year. The poet laureate will be funded a stipend of \$8,000 per year with a manageable number of required activities to perform.

For poetry programming \$24,000 will be utilized to offer monthly online classes that will encourage local poets to move to the next level of poetry, topics will include book publishing and promotion.

#### 6. Galleries:

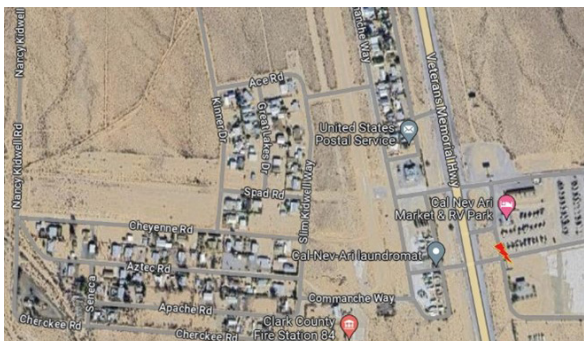

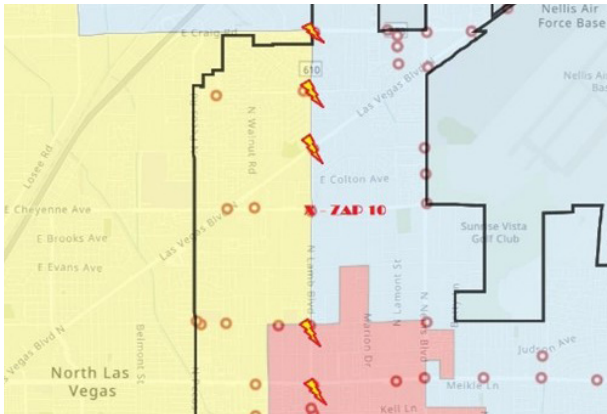
