## Advisory Committee Meeting Briefing- 9/21/2022

### Roadkill Grill II/Ammunition Status-

- Per conversation with John (Chuck) Frommer August 30, 2022, Roadkill Grill II tentatively set to return no later than March 1, 2023, with option to return January 1, 2023
- Ammunition arriving steadily in 12 gauge. Small gauge behind on deliveries. Prices still elevated on shotgun ammo. Metallic cartridges becoming reliable and seeing slight price drops

### Marketing-

- We've reactivated our Groupon account, and a ½ page ad appears in all Raider's home game programs.
- We're currently updating all event flyers online
- We're beginning to issue complimentary passes once again and will issue these to you this evening. You're encouraged to seek out first-time local visitors or tourists
- We're currently receiving online votes following nomination for "Best of Las Vegas" for best shooting range and place to take visitors. The Shooting Complex received "Gold" the past two years

### New & Existing Events Impacting Complex-

- Clay target prices and Range fees will both increase January 1, 2023. Expect stability in clay target prices by November 1, allowing us to recommend proper amount of increase to the BCC for approval at their December meeting
- Part-time staffing costs elevated unexpectedly during February 2022, with new minimum ROP established of \$12/hr. Result was immediate part-time staffing cost increase exceeding 20%
- Moving forward, our Indirect Costs, previously paid from the General Fund, will come out of our 5450 Shooting Complex account. This will add approximately \$200,000 to our annual expense. We'll continue to receive an annual \$250,000 subsidy based on an "as needed" basis. Our current Cash Balance is healthy
- Lead shot pellet reclamation scheduled for all trap & skeet fields between Thanksgiving and mid-Feb. The reclamation is projected to provide a windfall exceeding \$300,000 to our facility
- Nellis Rod & Gun Club has shut down indefinitely. Pro-Gun in Boulder City is questionable

- Several new, major youth events have scheduled clay target events at the Shotgun Center for 2023

### SNPLMA (Southern Nevada Public Lands Management Act)- Current considerations in final approval stage-

- Public Archery- includes 3000 sq ft building, field course, improvements to 3D n. loop for disabled access
- Education Center Archery- backstop treatment to accommodate firearms
- International Trap Bunker- state of the art to be constructed on existing field #24
- Helice (ZZ)- One completely equipped field for daily use, one adjacent field that may be equipped for event, shaded viewing area, parking lot expansion. To be constructed in location of current pattern board

### SNPLMA-Future considerations-

- Public Range expansion, 15-20 firing points on west side to relocate 3, 5, & 7-yard target frame holders to alleviate potentially dangerous ricochet factor plus provide additional public range firing points
- Phase I Tactical (must propose as a public benefit)
- Building on west side of Education Center (Allows indoor participation- NASP, Airsoft, Airgun, etc.,)

### Capital Improvement; Proposed Projects-

- Permanent outdoor restrooms for shotgun center
- Replacement of host shade canopy fabric
- Sporting clays trail parallel to paved roadway, relocation 40' west needed to avoid current watershed
- New parking area across road from Shotgun Center
