TERMS AND CONDITIONS FOR ALL COMMUNITY RESOURCES

1. Community Resources shall submit the application by Friday, January 12, 2024. If selected, payment will be due one week after approval, or space may be forfeited.
2. Community Resources are required to be open on February 18th by 11:00 a.m. for the duration of the entire event. Closing before or staying open after the end of the event is grounds for exclusion from participating at future events.
3. INDEMNIFICATION: Contractor agrees, by signing below, regardless of coverage

under any insurance policy, to pay all costs necessary to indemnify, defend and hold Clark County and/or the Las Vegas Metropolitan Police Department (as applicable) harmless from all claims, demands, losses, actions, attorney's fees, cost and expenses based on or arising out of any acts, errors, omissions, fault, or negligence of contractor or its principals, employees, subcontractors or other agents while performing services under this contract.

4. SUBLEASING: Community Resources/Vendors may not sublease their space, unless pre-arranged with Clark County Special Events. Sublease in this use includes renting, sharing, donating or in any way allowing another company or person to display or advertise in an exhibitor's space.
5. SALES TAX: Nevada State Law states that all vendors must pay sales tax on goods sold in Nevada. Vendors are responsible for keeping track of their sales, and paying current applicable Nevada State Sales Tax at the end of the event. If you are forced to close by any government agency for failure to obtain your necessary permits and/or licenses, Clark County is not liable and will not refund fees. NO EXCEPTIONS. Any questions should be directed to Nevada's Department of Taxation at 702-486-2300. Anyone failing to pay taxes will be prohibited from vending in future events.
6. **Consumption of alcoholic beverages or controlled substances by Community Resources /vendors at their booth is prohibited.** Under no circumstances are controlled substances allowed on the event site. Anyone with controlled substances in their possession on the event site is subject to immediate expulsion and /or arrest.
7. Set-up information will be e-mailed to you upon acceptance.
8. Community Resources must provide their own shade cover/tent.
9. No political signs are permitted.
10. No tents larger than 10' x 10' are permitted. Spots are 10' x 10'.
