If any member of the Art Committee wishes to extend the length of a presentation, it may be done by the Facilitator or the Committee by majority vote.
- III. Minutes - Review and approval of October 22, 2019, Meeting Minutes. (*for possible action*)
- IV. Agenda - Approval of Agenda. (*for possible action*)
- V. Introduce Committee Members – Each committee member introduces themselves and gives a short background of their experience in art and why they chose to be on the Public Art Committee. New board members Chase McCurdy and Frederic Bonin-Pissarro were approved by the BCC on November 5, 2019 agenda item #28. (*not an action item*)
- VI. Appointment of Chair and Vice Chair. Once a year the Art Committee appoints a chair and vice chair to the board. Currently the Chair position is vacant and the Vice Chair is Rebecca Holden. (*for possible action*)

In April the Art Committee votes on and makes a recommendation regarding the proposed art projects and appropriate budget for the projects.
